### **Requirements for Authorizing Work**

- State of Emergency Exists
- Damage Related to Storm
- Board Considers and Votes to Authorize Work
  - >Board must find some Public Purpose
  - >Board must separately authorize each project
- Determination of Public Purpose and connection to storm damage should assist with FEMA claims, if any
- Private Property Owners should provide written consent
