The Chairman called for the vote. The motion carried unanimously.

Commissioner DePratter inquired about interviews for the new ACM and offered comment on the new jail.

Commissioners Murphy and Williams also commented on the jail.

Commissioner Murphy stated that he had received a letter from Mr. Cason, Clerk of Courts, requesting that two Commissioners be appointed to the Value Adjustment Board and that one citizen be appointed. Commissioner Murphy asked for volunteers. Commissioners Nash and Murphy were appointed. Citizen Brad Dicks was appointed to the citizen representative.
