Central Communications – Motorola Solutions - Former Consent Item No. Four (4)

Due to changes in the scope of work, the completion date fell after the foliage was gone from the trees. The final testing should be completed with the foliage on the trees. The change order allows for a 5% payment when the system is turned over to the County and the final 5% when the final testing is completed in the Spring.

Discussion ensued.

MOTION by Commissioner Williams to adopt item number four r (4) of the consent agenda. SECOND by Commissioner Nash. The motion carried unanimously

Amendment to Personnel Policies and Procedures

Staff is requesting an amendment to the County Personnel Policies and Procedures Manual to add Chapter 49, Employee Emergency Duty Responsibilities. During times of emergencies and disasters, Columbia County must continue to provide essential and protective services to our community. All County employees have a role to play during such an incident even though these roles may not fit within their job

descriptions or may require work outside their normal work hours and location. Chapter 49 would define those duties.

MOTION by Commissioner Witt to amend the Columbia County Personnel Policies and Procedures Manual by adding Chapter 49, Employee Emergency Duty Responsibilities. SECOND by Commissioner Williams. The motion carried unanimously.

Revised Job Description – Sign Shop Foreman

The County has advertised for the position of Sign Shop Foreman; at this time there have been no qualified applicants. In an attempt to solicit qualified applicants, the position description has been revised to increase the minimum pay of the position from \$15.71 per hour to \$21.63 per hour.

Discussion ensued.

MOTION by Commissioner Nash to table this for two weeks until the next meeting. SECOND by Commissioner Witt. The motion carried unanimously.

Engineering Office Design - Build Project - RFP 2018-Q

The RFP is for design build of an approximately 1,500 square foot building to be constructed with interior build-out.

Discussion ensued.

MOTION by Commissioner Nash to approve RFP 2018-Q for a modular building only. SECOND by Commissioner Murphy.

Discussion ensued.

Citizens Crista Pribble and Stewart Lilker offered comment.

AMENDED MOTION by Commissioner Nash to reduce the size of the building to 1200 square feet. AMENDED SECOND by Commissioner Murphy. The motion carried by a vote of 3 to 2 with Commissioners Williams and Witt voting in opposition.

Courthouse Parking

First Baptist Church has offered to sell the building on the corner of Hernando Avenue and Highway 90 to the County for \$349,000 with a five (5) year lease for use of the empty lot on the corner of Vickers Terrace and Highway 90 for parking.

Citizens Sandra Smith and Stewart Lilker offered comment.

Discussion ensued.

MOTION by Commissioner Murphy to nominate Commissioner Witt as Vice Chairperson. SECOND by Commissioner Williams. The motion carried unanimously.
