MOTION by Commissioner Witt to approve request. SECOND by Commissioner Ford. The motion carried unanimously.

#### Commercial Solid Waste Collection

A dispute has arisen with a County franchisee and the County's contracted waste collector, Waste Pro of Florida, Inc. for commercial roll-off dumpster services within the County.

Citizen Robert Sheppard addressed the Board concerning his new franchise.

Kerri Bernhard and Robert Lisben, with Champion Homes addressed the Board with concerns about Waste Pro.

Frank Kramer with Waste Pro addressed the Board.

Discussion ensued. No Board action taken.

#### Closure of Unnamed Road

Request by the County Attorney to set a hearing on the petition by Hercules Maxwell to close an unopened, unnamed road north of NE Track Drive.

MOTION by Commissioner Nash to approve setting hearing on petition to vacate for May 2, 2019. SECOND by Commissioner Murphy. The motion carried unanimously.

## Rum Island Park

Staff requested that Rum Island Park be closed until renovations are complete due to vandalism and safety.

Discussion ensued.

MOTION by Commissioner Ford to do some renovations to the docks to make them safe for the public and to wait until after Labor Day to close the park for the other renovations. SECOND by Commissioner Witt. The motion carried unanimously.

#### Old Bellamy Road

A request by several property owners was made for the realignment of SW Old Bellamy Road.

Discussion ensued.

MOTION by Commissioner Ford to relocate Old Bellamy Road. SECOND by Commissioner Nash. The motion failed by a vote of 3 to 2 with Commissioners Murphy, Williams and Witt voting in opposition.

#### Intersection of Pinemount and Birley Road

Concept Development, Inc. has applied for a special exception for tax parcel 02778-002. There are concerns of traffic safety at the intersection of Pinemount and Birley roads. The developer has offered to pay for signalization at the intersection at a cost of \$153,822 and the County will be responsible for installing turning lanes at a cost of \$261,926.

Discussion ensued.

MOTION by Commissioner Ford to approve development agreement with Concept Development Inc. SECOND by Commissioner Nash. The motion carried unanimously.

Citizen Zola Henry offered comment.

## **Engineering Office**

After a review of the RFP's received, staff recommended awarding the project to Swartz Building Solutions, Inc. in the amount of \$95,744.

Discussion ensued.

MOTION by Commissioner Nash to approve staff recommendation. SECOND by Commissioner Murphy. The motion carried by a vote of 3 to 2 with Commissioners Ford and Williams voting in opposition.

## Resolution No. 2019R-8

A resolution approving State of Florida, Department of Transportation, supplemental reimbursement agreement with Columbia County Florida to facilitate construction of Bell Road in Columbia County.

MOTION by Commissioner Nash to approve Resolution No. 2019R-8. SECOND by Commissioner Witt. The motion carried unanimously.

#### Richardson Recreation Center

Staff recommended awarding Bid No. 2018-5 for the Richardson Recreation Center court renovation to the low bidder, Live Oak Management Group in the amount of \$52,871.50.

Commissioner Witt declared a conflict.

MOTION by Commissioner Nash to award Bid No. 2018-5 to Live Oak Management Group. SECOND by Commissioner Murphy. The motion carried by a vote of 4 to 0 with Commissioner Witt abstaining.

#### City/County Planning Committee

The City and the County agreed to a cooperative planning committee. Staff is recommending the following positions for that committee:

MOTION by Commissioner Nash to approve joint City-County Cooperative Planning Committee. SECOND by Commissioner Murphy. The motion carried unanimously.

## Alligator Lake Public Small Game Hunting Area

Staff is recommending approval of a request to include the Alligator Lake Public Small Game Hunting Area in alligator hunting this fall for persons possessing a Columbia County Alligator Harvest Unit and increasing the number of permits from four (4) to six (6).

MOTION by Commissioner Witt to approve. SECOND by Commissioner Nash. The motion carried unanimously.

#### BA 19-42 Welcome Center Renovations

Staff requested approval to allocate funds to cover removing the decorative steel from the roof of the building and installing coping to prevent rain leaking into the building.

MOTION by Commissioner Nash to approve BA 19-42. SECOND by Commissioner Murphy. The motion carried unanimously
