Re: SCRAP, SCOP, CIGP projects for Town of Fort White

Date: March 6, 2024

At its November 16, 2023, meeting, Mr. Kirby addressed the Board concerning four interlocal agreements with the Town of Fort White (the "Town") for administration of FDOT grant projects (SCRAP, SCOP, CIGP, LAP, MSCOP). As of that meeting, the Board had recently adopted a motion that would potentially terminate all interlocal agreements with the Town, including these four project agreements.

As Mr. Kirby explained at that meeting, the four projects were in progress, and terminating the interlocal agreements would have been disruptive to the projects. Staff was concerned that withdrawing from those interlocal agreements would damage the County's relationships with FDOT. The Board then approved completion of the four interlocal agreements concerning the FDOT projects.

Typically, public works asks the Board to consider FDOT grant projects for the County at the end of the calendar year. While staff have tried in years past to have these presentations include potential projects with the Town, those projects were usually submitted in February or March.

On March 4, 2024, the County Engineer received an email from the Town, requesting "Would you please give NFPS whatever authorization they are needing to submit the applications for SCRAP, SCOP. CIGP for the Town of Fort White?" This is the first request the County had received concerning projects for the Town for the coming cycle, and the first time since November the County had been asked to participate with those projects in a manner that would require County authorization. The deadline for submitting signed, final paperwork to FDOT for this year's submittals is March 15, 2024. The projects the Town wishes the County to "authorize" are listed on the attached sheet and include LAP and MSCOP projects.

Staff is requesting immediate direction from the Board concerning the four proposed projects. The Board's last direction was to complete the four projects that were already in progress but gave no additional authorization for new projects.
