# **Columbia County Board of County Commissioners**

Annual Report of the County Manager For Fiscal Year 2016



• The Annual Report is required under Section 3.3 (2) of the Home Rule Charter for Columbia County.

#### FY 2015 – 2016 RECOMMENDATIONS UPDATE

• Continue to hold multiple workshops. This practice has worked well over the past several years.

UPDATE: The County conducted budget workshops on April 21, 2016, May 19, 2016 and. In addition, the Board held a workshop on August 18, 2016 to receive the 2017 proposed floor budget.

These workshops prove to be beneficial. They allow proper time to vet and discuss issues. Furthermore, they allow time for staff to provide background and research information when requested.

• Continue to review and develop policy. This is particularly true of current leave policies. The objective is to change current leave policies to "Paid Time Off".

UPDATE: In lieu of "Paid Time Off" staff recommended. and the Board approved, an employee leave buyback program, along with policy revisions for required verified sick leave. Failure for verified sick leave may lead to disciplinary actions for possible abuse of leave.

• Develop and implement communication improvements. Partial funding has been appropriated in the FY 15-16 budget to begin this project.

UPDATE: FY 16-17 budget including \$6,000,000 for fully funding a P25 compliant communications system.

• Develop a consensus on necessary jail improvements. This consensus should be developed in cooperation with the county's Public Safety Coordinating Council (PSCC). Planning should include cost estimates and possible funding options.

UPDATE: Currently the County has contracted with the Architectural firm of Clemons Rutherford and Associates to make recommendations to the PSCC. Recommendations should occur in the first quarter of 2017.

• Review the recently implemented Insurance Servicing Organization (ISO) compliance enhancements to the Columbia County Fire/Rescue Department. The goal is to make sure all changes are working as planned and to make changes as needed to insure compliance.

UPDATE: Upon review with county consultant, National Fire Services Office, it was determined that some revisions to the County Fire Services plan could be made to insure effective compliance with ISO ratings. During the FY 16-17 staff will review and make recommendations to the Board.

• Develop procedures for evaluating economic development projects. The purpose of these procedures is allow for a proper cost-benefit review of all proposed projects.

UPDATE: The Economic Development Advisory Board is currently working on these procedures for Board consideration.

• Develop and implement a final plan to enhance the U.S. 41/I-75 interchange at Ellisville.

UPDATE: Staff has recommended the following actions for Ellisville: Create a Tax Increment Fund (TIF) Program to benefit the interchange, Roadway Enhancements, Branding, Special Planning Area, Utilities Improvements. Concentrated efforts have been placed on the utilities improvements. Currently the County has an upcoming bid for the sewer plant expansion and improvements. Staff is continuing to work towards the other items listed.

- Continue discussions to find solutions for the following ongoing budget issues:
  - 1.) Road Improvements
  - 2.) Repair/Replacement Columbia County Detention Center

UPDATE: 1.) Road Improvements – funding for Road Improvements continues through excess reserves and Florida Department of Transportation grant programs. Without a dedicated funding source future needs may go unfunded.

- 2.) Once recommendations for the detention center have been accepted the Board will need to determine how to fund the repair/replacement. This should be known in time for next FY budget workshop discussions.
- Continued policy review/development is recommended in the following areas:
  - 1.) Safety The goal would be to strengthen the current policy in order to impact Workers Compensation mod rates.

UPDATE: Board members have been presented copies of suggested changes for their comment. These policies will be recommended for approval at a future Board meeting.

2.) Public Buildings(s) Signage Policy – Adopt standards for the type of signage to be erected at buildings under the control of the Board of County Commissioners. The intent is to standardize and to create an identity based on buildings use.

#### FY 2015-2016 FINANCIAL REVIEW

- The audit for the period ending September 30, 2016 is underway and will be presented to the Board once complete.
- FY 2015-2016 began with \$265,753 in additional advalorem revenue over the previous year. No new taxes were adopted. The adopted millage levy represented a .03% reduction. No other fees or assessments were increased.

#### FY 2016-2017 BUDGET ISSUES

- County reserves are being maintained at a healthy level. Excess reserves are continuing to be utilized to fund equipment replacement and make capital improvements.
- Columbia County does not have an identified revenue source for road improvement projects. Staff has advised that roads in need of resurfacing are becoming an issue.
- Insurance and retirement costs are expected to continue increase.
