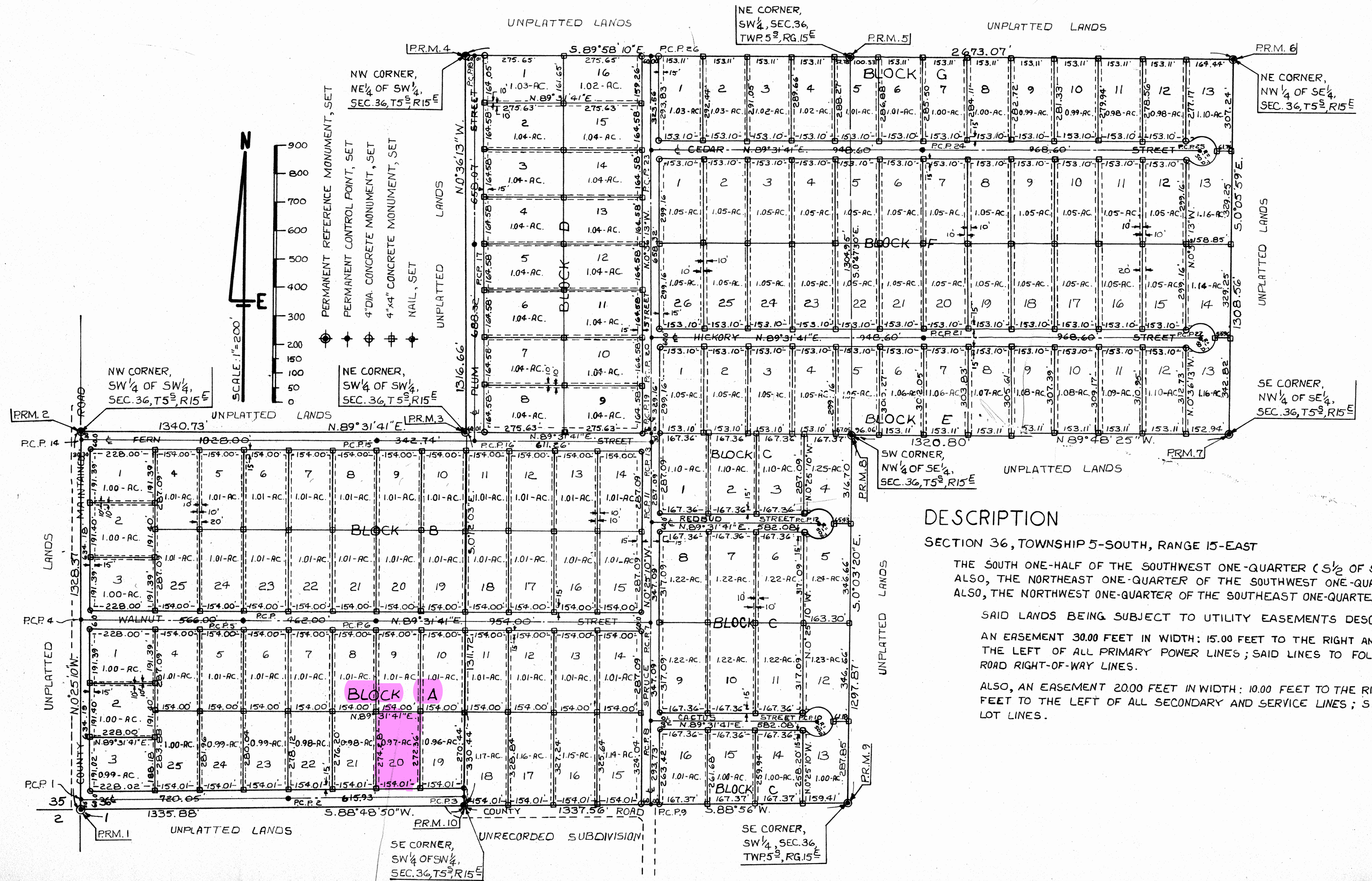

SAID LANDS BEING SUBJECT TO UTILITY EASEMENTS DESCRIBED AS FOLLOWS: AN EASEMENT 30.00 FEET IN WIDTH; 15.00 FEET TO THE RIGHT AND 15.00 FEET TO THE LEFT OF ALL PRIMARY POWER LINES; SAID LINES TO FOLLOW STREET AND ROAD RIGHT-OF-WAY LINES.

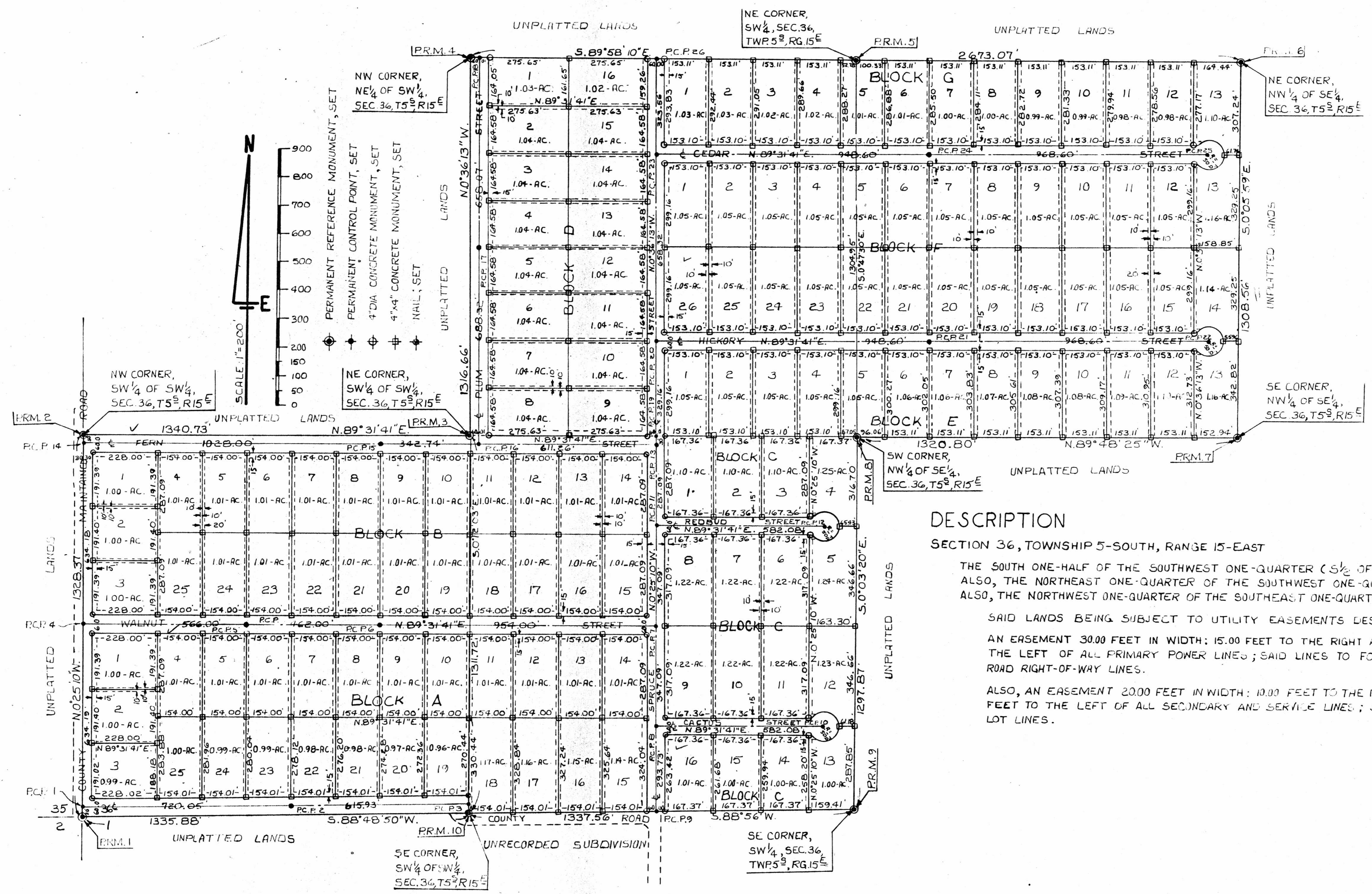

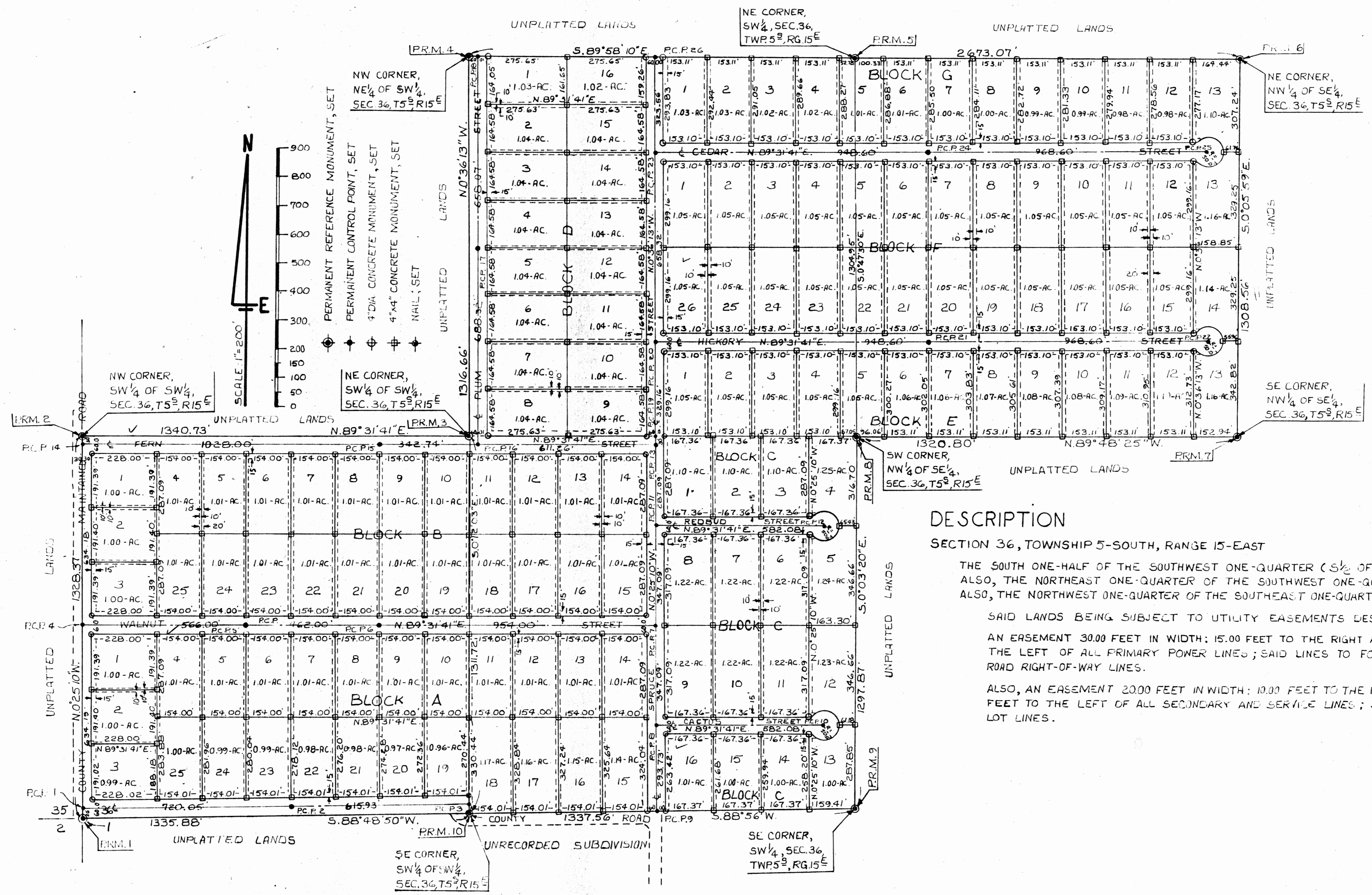
