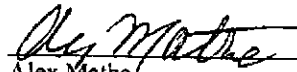

LESS AND EXCEPT: PART OF THE NORTHEAST 1/4 OF SECTION 35, TOWNSHIP 4 SOUTH, RANGE 15 EAST, COLUMBIA COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: FOR A POINT OF REFERENCE, COMMENCE AT THE NORTHEAST CORNER OF SAID SECTION 35, THENCE RUN SOUTH 00 DEGREES 44'11" EAST ALONG THE EAST LINE OF SAID SECTION 35, A DISTANCE OF 97.64 FEET TO THE NORTHEAST CORNER OF LOT 5 OF CYPRESS LAKE HILLS, A SUBDIVISION RECORDED IN PLAT BOOK 5, PAGE 82, OF THE PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA, AND THE POINT OF BEGINNING; THENCE CONTINUE SOUTH 00 DEGREES 44'11" EAST ALONG SAID EAST LINE OF SECTION 35, BEING ALSO THE EAST LINE OF SAID CYPRESS LAKE HILLS, A DISTANCE OF 24.38 FEET; THENCE NORTH 89 DEGREES 52'54" WEST, A DISTANCE OF 226.22 FEET TO A POINT ON A CURVE CONCAVE TO THE SOUTH HAVING A RADIUS OF 9960.00 FEET; THENCE RUN ALONG AND AROUND SAID CURVE A CHORD BEARING AND DISTANCE OF NORTH 89 DEGREES 55'13" WEST, 13.38 FEET TO A POINT ON THE EAST RIGHT OF WAY LINE OF SW HORSE WAY, BEING ALSO THE WEST LINE OF SAID LOT 5; THENCE NORTH 00 DEGREES 43'41" WEST ALONG SAID EAST RIGHT OF WAY LINE, BEING ALSO SAID WEST LINE OF LOT 5, DISTANCE OF 25.47 FEET TO THE NORTHWEST CORNER OF SAID LOT 5; THENCE SOUTH 89 DEGREES 37'22" EAST ALONG THE NORTH LINE OF SAID LOT 5, A DISTANCE OF 239.62 FEET TO THE POINT OF BEGINNING.
