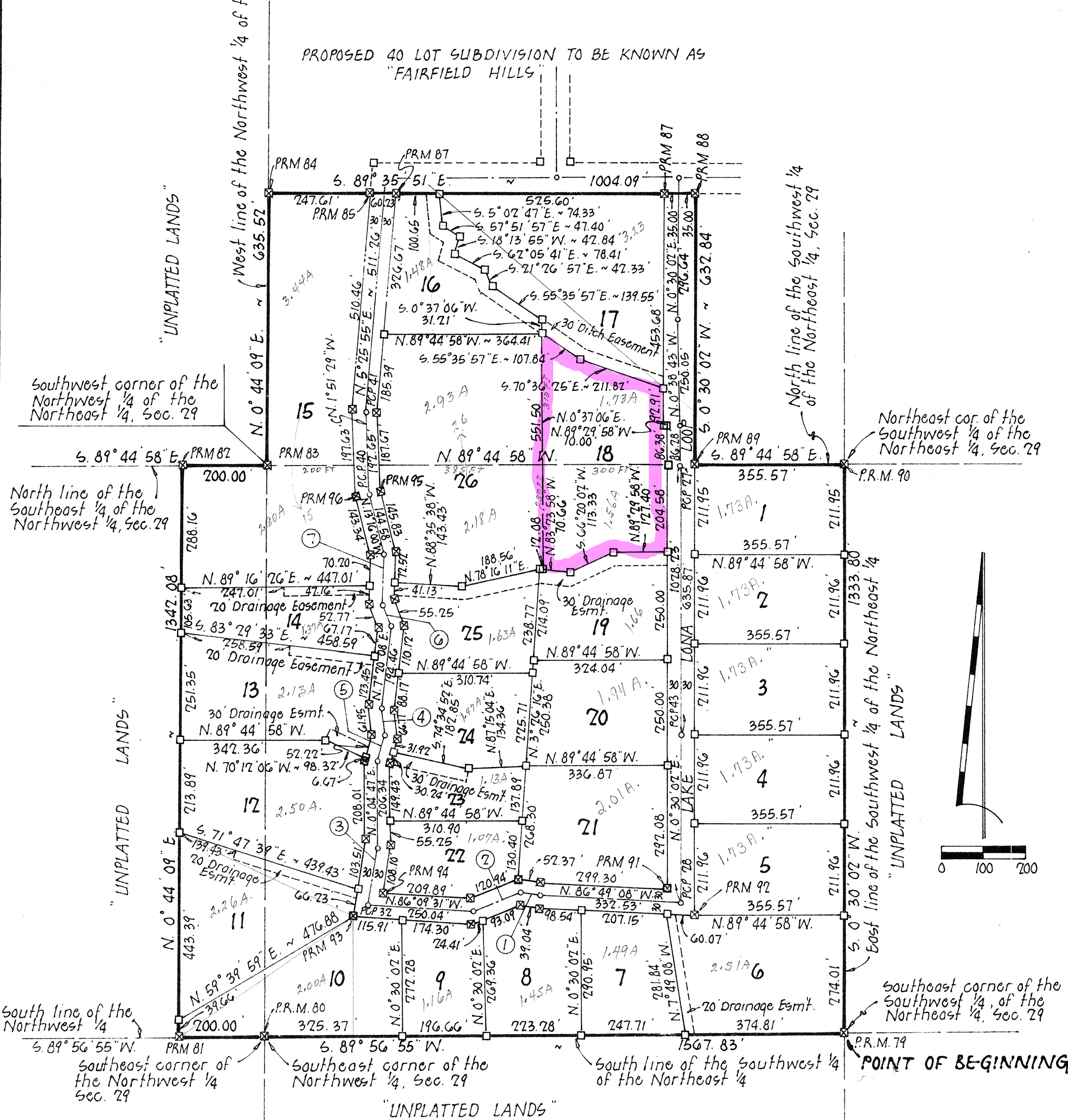

DESCRIPTION:

BEGIN at the Southeast corner of the Northwest 1/4, Section 29, Township 3 South, Range 16 East, Columbia County, Florida and run S. 89° 56' 55" W. along the South line of said Northwest 1/4 a distance of 200.00 feet; thence N. 0° 44' 09" E. 1347.08 feet to the North line of the Southeast 1/4 of the Northwest 1/4, Section 29; thence S. 89° 44' 58" E. along said North line 200.00 feet to the Southwest corner of the Northwest 1/4 of the Northeast 1/4; thence N. 0° 44' 09" E. along the West line of said Northwest 1/4 of the Northeast 1/4 a distance of 635.57 feet; thence S. 89° 35' 51" E. 1004.09 feet; thence S. 0° 30' 02" W. 632.84 feet to the North line of the Southwest 1/4 of the Northeast 1/4, Section 29; thence S. 89° 44' 58" E. along said North line 355.57 feet to the Northeast corner of said Southwest 1/4 of the Northeast 1/4, Section 29; thence S. 0° 30' 02" W. along the East line of said Southwest 1/4 of the Northeast 1/4 a distance of 1333.80 feet to the Southeast corner of said Southwest 1/4 of the Northeast 1/4, Section 29; thence S. 89° 56' 55" W. along the South line of said Southwest 1/4 of the Northeast 1/4 a distance of 1367.83 feet to the POINT OF BEGINNING.
