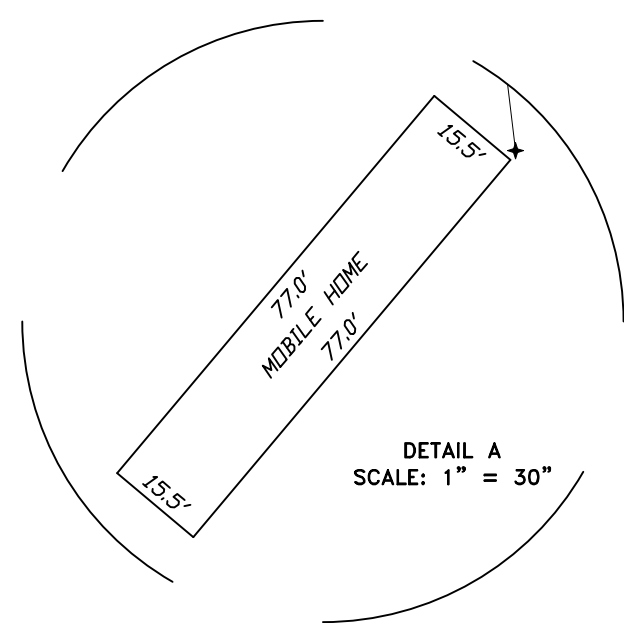


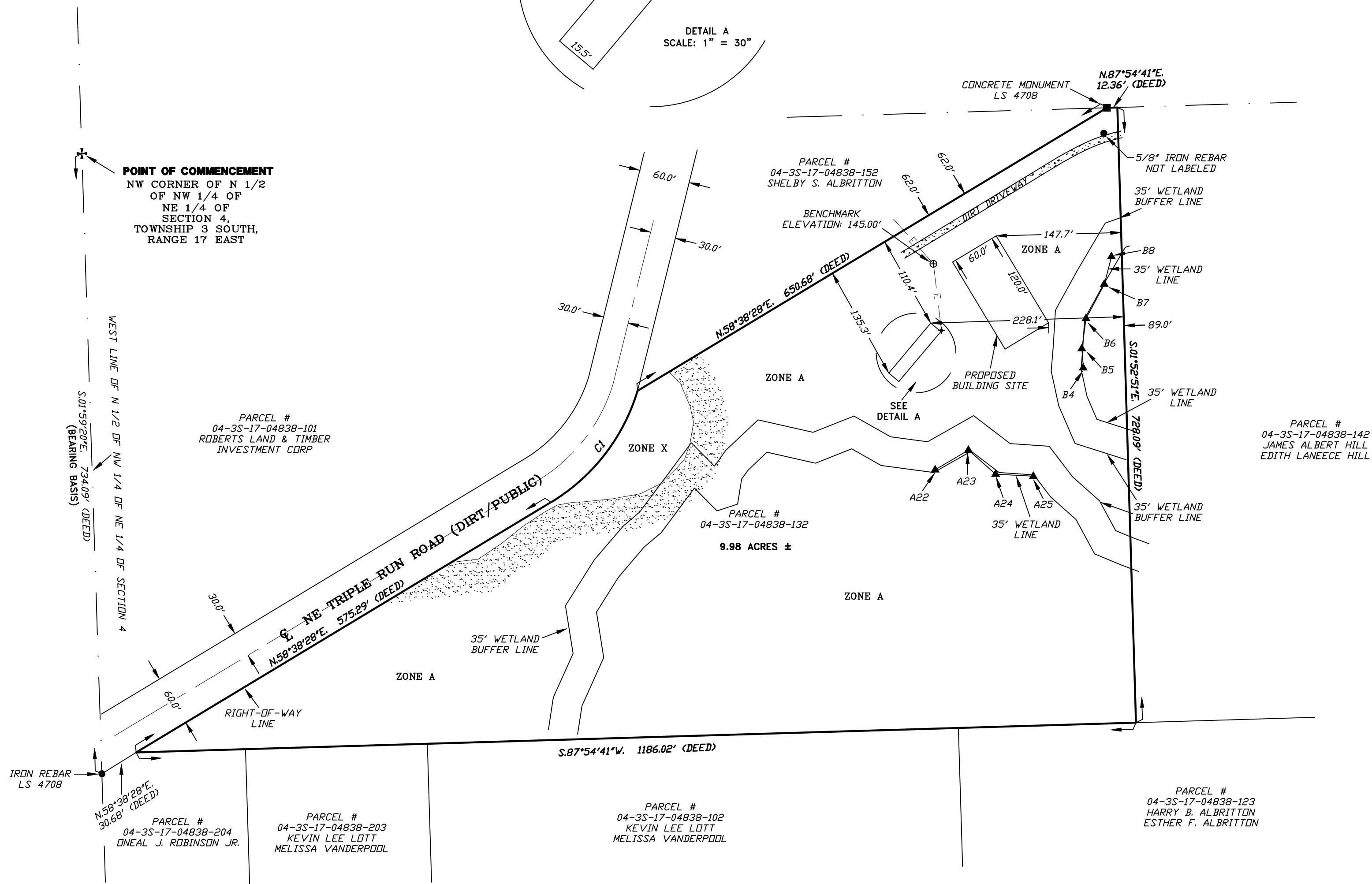
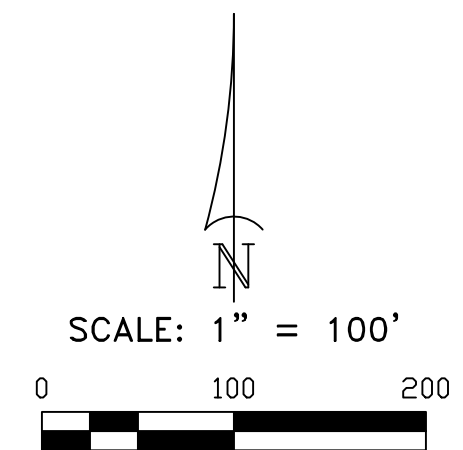

DESCRIPTION:

COMMENCE AT THE NORTHWEST CORNER OF THE NORTHWEST ONE-QUARTER (NW 1/4) OF THE NORTHEAST ONE-QUARTER (NE 1/4) OF THE NORTH ONE-HALF (N 1/2) OF SECTION 4, TOWNSHIP 3 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLORIDA, THENCE RUN S.01°59'20"E., ALONG THE WEST LINE OF SAID NW 1/4 OF THE NE 1/4 OF THE N 1/2 OF SAID SECTION 4, A DISTANCE OF 734.09 FEET TO A POINT ON THE SOUTHERLY RIGHT-OF-WAY LINE OF NE TRIPLE RUN ROAD (A COUNTY MAINTAINED DIRT ROAD); THENCE N.58°38'28"E., ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE A DISTANCE OF 30.68 FEET FOR A POINT OF BEGINNING; THENCE CONTINUE N.58°38'28"E., ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE, A DISTANCE OF 575.29 FEET TO THE POINT OF CURVE OF A CURVE TO THE LEFT HAVING A RADIUS OF 233.13 FEET AND A CENTRAL ANGLE OF 42°02'39", THENCE NORTHEASTERLY, ALONG THE ARC OF SAID CURVE AND BEING SUBTENDED BY A CHORD BEARING AND DISTANCE OF N.37°37'09"E., 167.26 FEET WITH AN ARC DISTANCE OF 171.07 FEET TO THE END OF SAID CURVE; THENCE N.58°38'28"E., 650.68 FEET TO A POINT ON THE NORTH LINE OF SAID N 1/2; THENCE N.87°54'41"E., ALONG THE SAID NORTH LINE, A DISTANCE OF 12.36 FEET; THENCE S.01°52'51"E., 728.09 FEET; THENCE S.87°54'41"W., 1186.02 FEET TO THE POINT OF BEGINNING.
