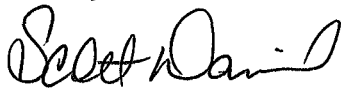

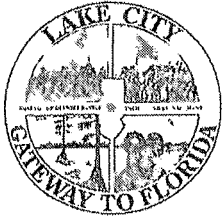
- The construction plans requires the minimum finish floor elevation to be 165.7'.

Finish Floor Elevation Certification

For: Columbia County Building Department

Parcel Number: 36-3S-16-02626-002

Description of Project:

The project is located on 3.91 acres off of US 90 in Lake City, FL

Existing Conditions:

An existing building is located near the NW corner of the property near US 90. The finish floor elevation of this building is +/-165.7.

The highest elevation restricting drainage to US 90 is +/-164.9

The lowest elevation at FDOT right of way adjacent to the property is +/-164.0

The topography of most of the property slopes away from US 90 and the existing building to the rear of the property and an existing low area south of the existing paved area +/- 113' of the northern portion of the property drains to US 90

A portion of the property is shown to be within a Flood Zone A according to FEMA Flood Maps (Panel 12023C0291C).

Historical Flood Data

According to neighbor's accounts of recent historical floods (Tropical Storm Debby 2012, Hurricanes Frances and Jeanne), flood waters never reached higher than the southernmost edge of pavement on the site (elevation +/-162.0). The combination of Frances and Jeanne in 2004 is considered to be greater than a 100 year storm event

Certification:

The estimated 100 year base flood elevation associated with the flood zone on this property is +/- **162.5'**

Although a portion of the existing building is shown to be within a Flood Zone A according to FEMA Flood Maps, it can be reasonably assured the finish floor elevation of the building is actually above the 100 year base flood elevation of the adjacent flood zone. The proposed building finish floor elevation is 165.8'.

The above certification is based on the existing conditions and historical flood data described above. Elevations and topographic information are based on a survey provided by Donald F. Lee and Associates.

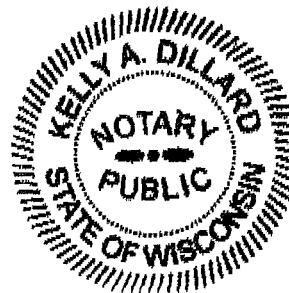

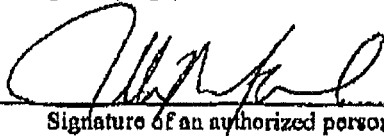

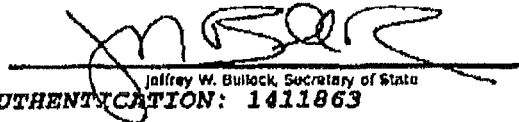
