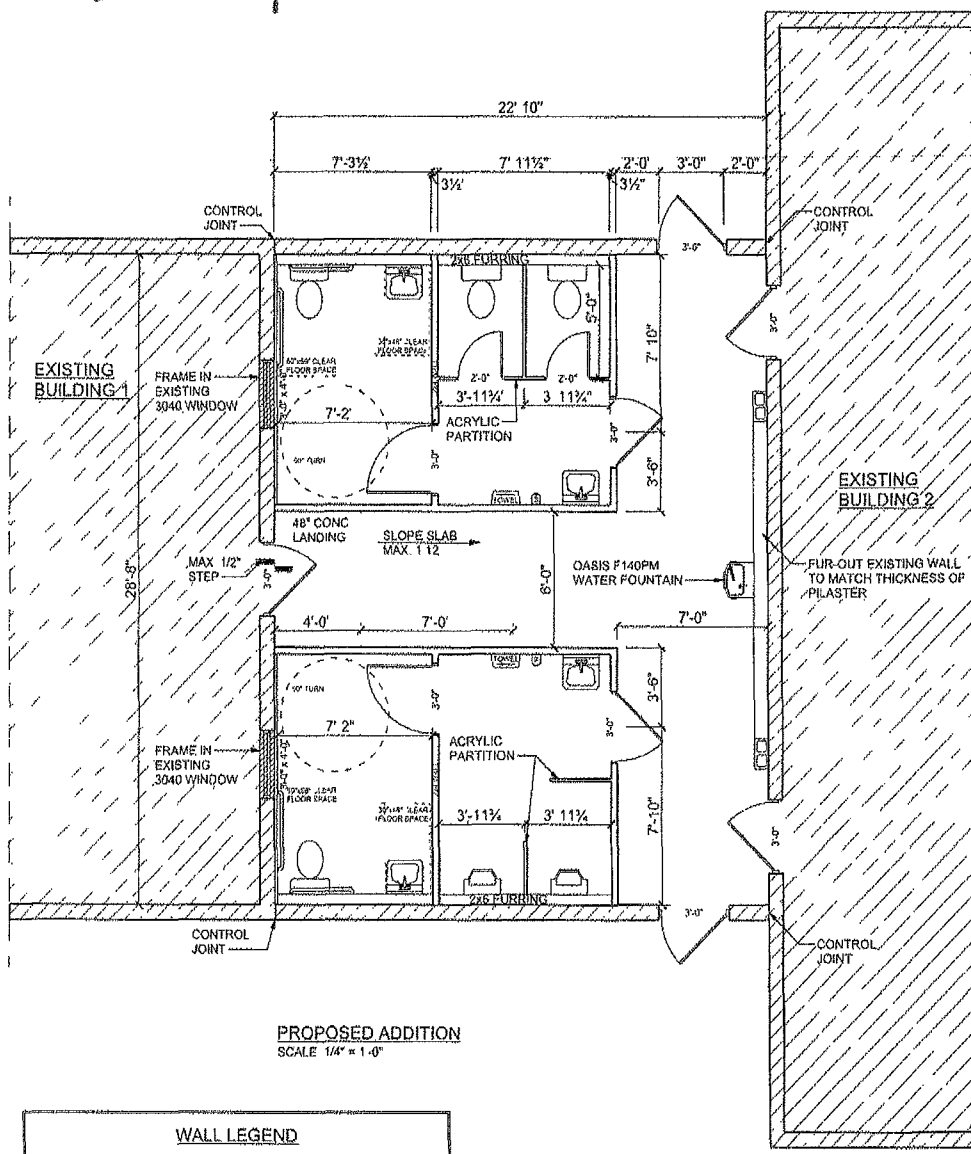

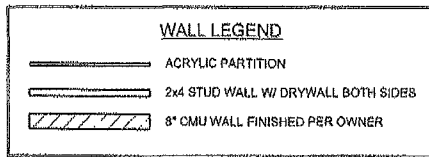

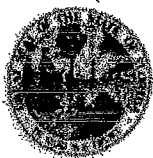
PROPOSED ADDITION

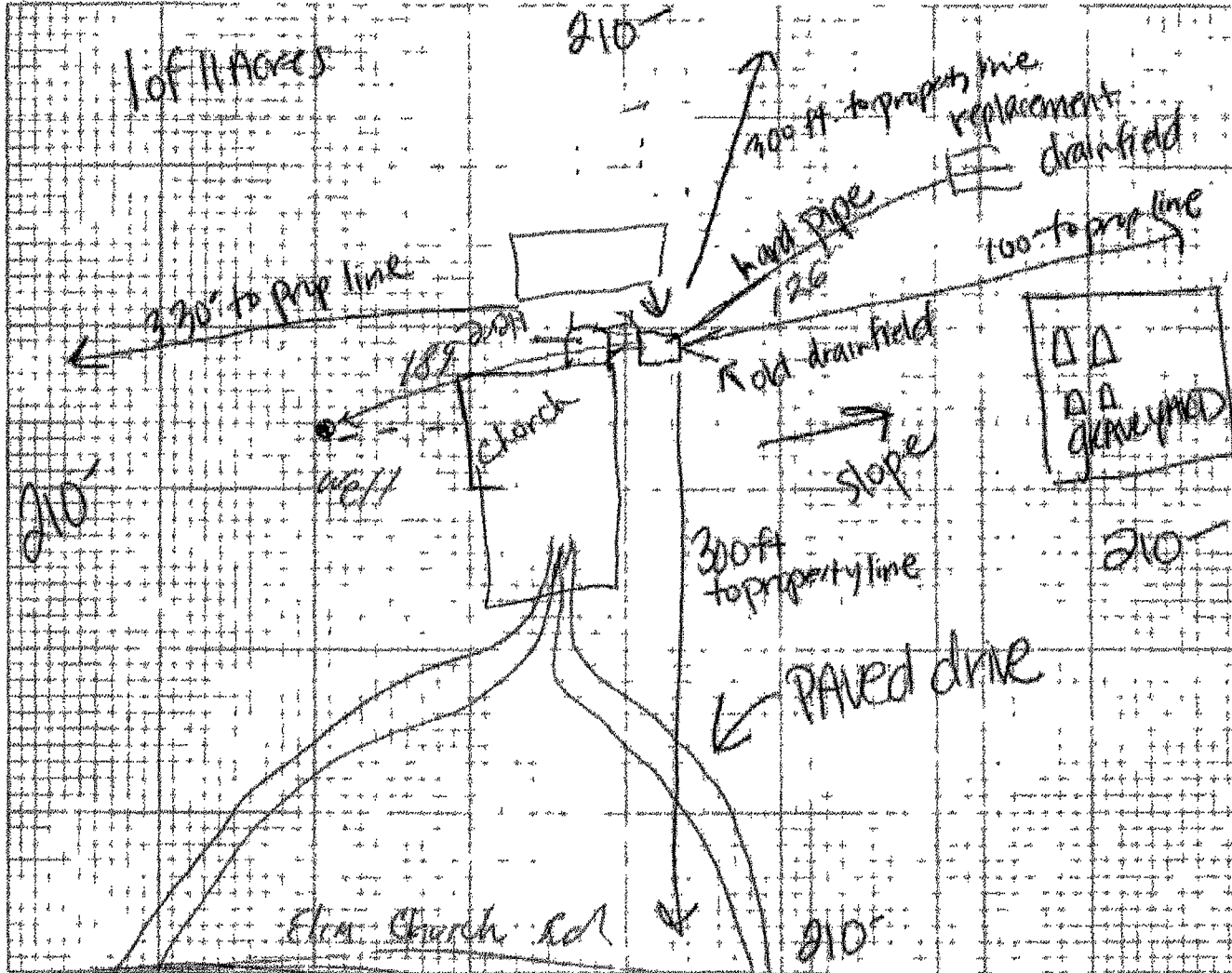
