

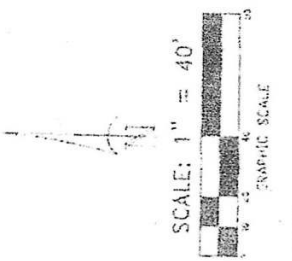
# Site plan for Parcel Id# 21-75-17-10040-000

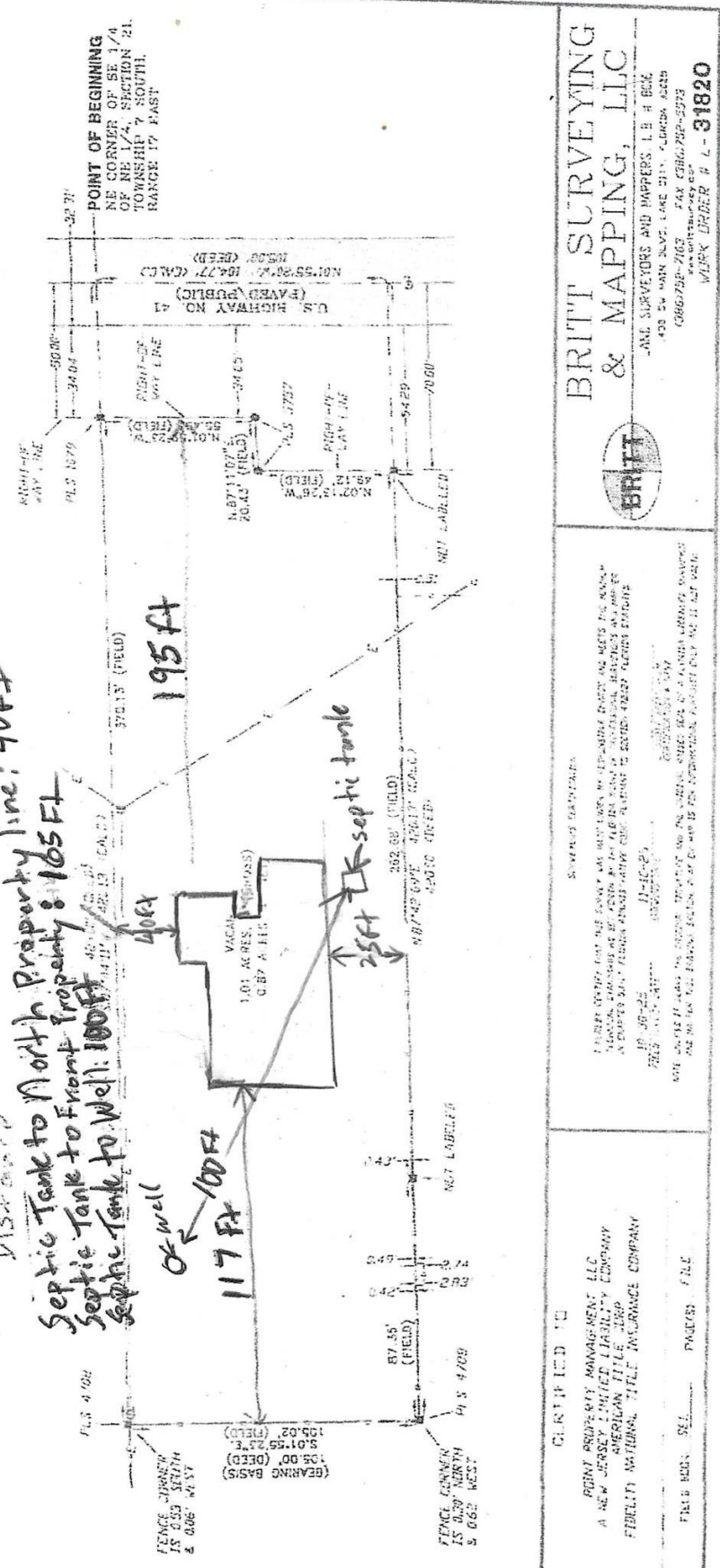
