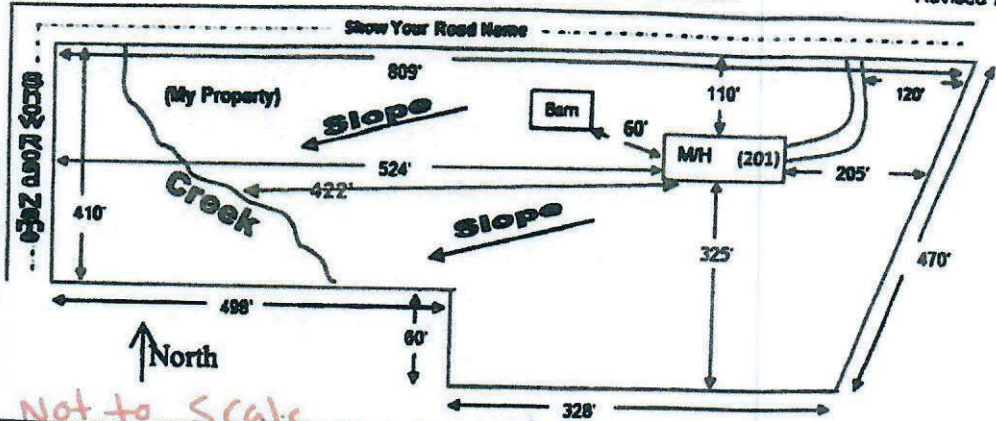

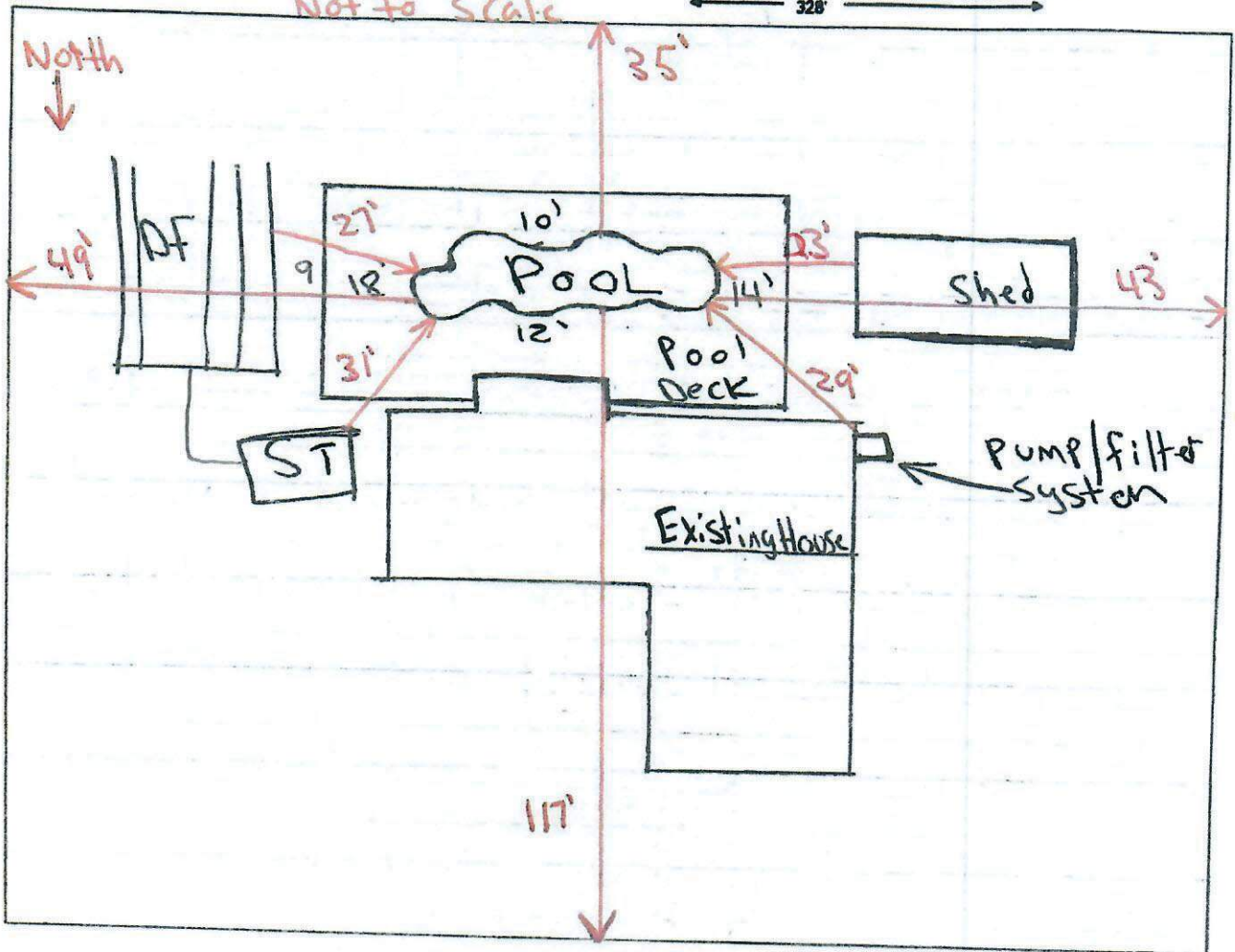
**SITE PLAN EXAMPLE**
