PARCEL B

COMMENCE at the Northeast corner of Lot 14, Cypress Lake Phase 3, a subdivision according to plat thereof as recorded in Plat Book 6, Page 80 of the Public Records of Columbia County, Florida; thence run North 88°18'28" East, along the Easterly extension of the North line of said Cypress Lake Phase 3 and the North Line of the Southeast 1/4 of Northwest 1/4 of said Section 33, a distance of 204.36 feet; thence run North 06°44'47" East, a distance of 192.79 feet to the Southerly Right-of-Way line of West U.S. Highway 90; thence run South 59°25'30" East, along said Southerly Right-of-Way line, a distance of 38.39 feet to a point of a curve; thence run Easterly along said Southerly Right-of-Way along the arc of said curve concave to the Northeast having a radius of 5799.60 feet, a central angle of 05°48'07", a chord bearing and distance of South 62°18'28" East 587.03 feet, an arc distance of 587.28 feet to a point of tangency; thence South 65°12'40" East, along said Southerly Right-of-Way line, a distance of 216.11 feet to the POINT OF BEGINNING; thence South 65°12'40" East continuing along said Southern Right-of-Way line, a distance of 358.85 feet; thence South 24°46'56" West a distance of 271.36 feet; thence North 75°50'52" West a distance of 183.06 feet to a point of curvature of a curve concave Northeasterly having a radius of 575.00 feet, thence run Northwesterly along the arc of said curve through a central angle of 01°31'12", a distance of 15.25 feet; thence North 14°52'41" East a distance of 66.26 feet; thence North 24°39'22" East a distance of 140.49 feet; thence North 20°16'51" West a distance of 33.61 feet; thence North 65°12'52" West a distance of 121.11 feet to a point of non-tangency on a curve concave Northwesterly having a radius of 50.00 feet, a chord bearing North 19°27'57" East and a chord distance of 78.60 feet, thence run Northeasterly along the arc of said curve through a central angle of 103°38'04", a distance of 90.44 feet to the POINT OF BEGINNING.
