IN SECTION 8, TOWNSHIP 5 SOUTH, RANGE 16 EAST COLUMBIA COUNTY, FLORIDA

DESCRIPTION:

BEGIN at the Northeast Corner of Section 8, Township 5 South, Range 16 East, Columbia County, Florida and run $5^{\circ}48'44''$ E. along the East line of said Section 8 a distance of 306.03 Feet to the South line of Lee Dairy Road (a 50 Foot County Graded Road); thence $N.87^{\circ}28'37''$ W. along said South line, Lee Dairy Road 300.41 Feet; thence $5^{\circ}48'44''$ E. 598.64 Feet; thence $N.89^{\circ}06'56''$ E. 299.90 Feet to East line, Section 8; thence $5^{\circ}48'44''$ E. along said East line, Section 8 a distance of 1753.04 Feet to the Southeast Corner of the Northeast $\frac{1}{4}$, Section 8; thence run $S.89^{\circ}03'16''$ W. along the South line of said Northeast $\frac{1}{4}$ a distance of 2648.68 Feet to the Southwest Corner of said Northeast $\frac{1}{4}$ (also being the Southeast Corner of the Northwest $\frac{1}{4}$, Section 8); thence continue $S.89^{\circ}03'16''$ W. along the South line of said Northwest $\frac{1}{4}$ a distance of 1983.36 Feet; thence $N.0^{\circ}25'06''$ W. 721.93 Feet; thence $N.89^{\circ}04'11''$ E. 601.37 Feet; thence $N.0^{\circ}23'51''$ W. 601.76 Feet to a Concrete Monument at its intersection with the North Line of the Southwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$; thence $S.89^{\circ}05'07''$ W. 601.60 Feet along said North Line of the Southwest $\frac{1}{4}$ of Northwest $\frac{1}{4}$ to a concrete Monument; thence $N.0^{\circ}25'06''$ W. 951.83 Feet to the North Right of way line of Lee Dairy Road (an existing County Graded Road having a 50 foot maintained Right of Way), said point being also on the arc of a curve concave to the left having a radius of 2441.50 feet and a central angle of $3^{\circ}14'40''$; thence run Southeasterly along the arc of said curve (being also said North Right of way line Lee Dairy Road) 138.76 Feet to the Point of Tangency of said curve; thence $S.66^{\circ}10'19''$ E. still along said North Right of way line 210.87 Feet to the Point of curve of a curve concave to the left having a radius of 196.87 feet and a total central angle of $40^{\circ}59'55''$; thence Easterly along the arc of said curve (still along said North Right of Way) 140.87 Feet to the Point of Tangency of said curve; thence $N.72^{\circ}49'46''$ E. still along said North Right of way line 315.52 Feet to the Point of Curve of a curve concave to the right having a radius of 4182.37 feet and a central angle of $5^{\circ}46'36''$; thence Northeasterly along the arc of said curve (still along said North Right of Way line) 213.10 Feet; thence $N.0^{\circ}23'51''$ W. 388.63 Feet to the North line of the Northwest $\frac{1}{4}$ of said Section 8; thence $N.89^{\circ}06'58''$ E. along said North line of the Northwest $\frac{1}{4}$, Section 8 a distance of 1024.17 Feet to the Northeast Corner of said Northwest $\frac{1}{4}$, Section 8 (also being the Northwest Corner of the Northeast $\frac{1}{4}$, Section 8); thence $N.89^{\circ}10'38''$ E. along the North line of said Northeast $\frac{1}{4}$, Section 8 a distance of 2627.59 Feet to the POINT OF BEGINNING.

 COMMENCE at the Northwest Corner of the Northeast $\frac{1}{4}$ of Northeast $\frac{1}{4}$, Section 8, Township 5 South, Range 16 East, Columbia County, Florida and run $S.0^{\circ}35'01''$ E. along the West line of said Northeast $\frac{1}{4}$ of Northeast $\frac{1}{4}$ a distance of 127.00 Feet to the POINT OF BEGINNING; thence $N.88^{\circ}28'06''$ E. 597.20 Feet; thence $S.0^{\circ}41'52''$ E. 669.55 Feet; thence $S.88^{\circ}28'06''$ W. 734.69 Feet; thence DUE NORTH 669.72 Feet; thence $N.88^{\circ}28'06''$ E. 129.33 Feet to the POINT OF BEGINNING.
