Answers to Questions/Inquiries

1. On page 21, it references a “Scrutinized Companies Certification Form” which is not included in the checklist and there is no form attached. Where can we find that form?
 - **Included in Addendum – this is a supplemental form that will be required with the proposal**
2. Aside from the resumes and reference letters, are the firm's licenses, certifications, and the RFQ forms also excluded from the 20-page limit for this submittal?
 - **Correct – The RFQ Forms should be limited to Pages 28-29, 31-48**
3. There is an extra form within the back of the packet on page 47 called “Required Policy Endorsements and Documentation” but it isn’t referenced anywhere else. Does that need to be included since it doesn’t appear on the checklist?
 - **This is in reference to the Insurance Requirements, please include.**
4. Will the County please replace the language on page 51, item 9a with the same indemnification language used on page 18 of the RFQ?
 - **Page 51 is a draft contract template – if change will be required, updates will take place once awarded and contract approved by the Board of County Commissioners**
5. Is it acceptable if our “team/subs” can meet the Minor Work Groups *if the proposing firm is not* FDOT pre-qualified in a few of the minor work services, and we normally sub those out?
 - **Yes, This would be acceptable given the subs are pre-qualified in the minor work groups.**
6. Specifically, we noticed that 9.4 is listed in the RFQ but is not mentioned on the FDOT prequal directory site. Could you please confirm if the county plans to remove this requirement?
 - **Work Group 9.4 is an all-encompassing header for Foundation Studies. Whereas Work Group 9.4.1, Standard Foundation Studies, is the specific pre-qualification requirement requested to be met. Therefore, please use Work Group 9.4.1.**
