

## Warranty Deed

**Together With** all tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.


**Subject To** taxes for the current tax year and subsequent years, not yet due and payable; covenants, restrictions, reservations and limitations of record, if any.


**To Have And To Hold**, the same in fee simple forever.
