The mechanical and electrical contractors shall coordinate the electrical characteristics of all mechanical equipment prior to ordering of equipment. No additional payment will be made for lack of contractor coordination of electrical characteristics.<br>10. All mechanical and electrical system components shall be routed tight to underside of structure and through joists or trusses where possible. Coordinate installation to preserve headroom, equipment access, and architectural clearances for finishes, including ceiling heights. Coordinate with all other trades and do not conflict with the architectural requirements for the finished construction. Provide offsets where required to coordinate with other trades.<br>11. Refer to architectural reflected ceiling plans for locations of all grilles and diffusers.<br>12. Operation and maintenance manuals: three (3) bound sets of the operation and maintenance manuals shall be provided to the construction representative at turnover, and are required for final acceptance.<br>13. As built drawings: the HVAC subcontractor shall progressively record all HVAC drawing changes which shall be available at all times for review by the construction representative. An AutoCAD copy of the final as-built drawings shall be provided to the construction representative at turnover. This AutoCAD as-built is required for final acceptance of the project. |

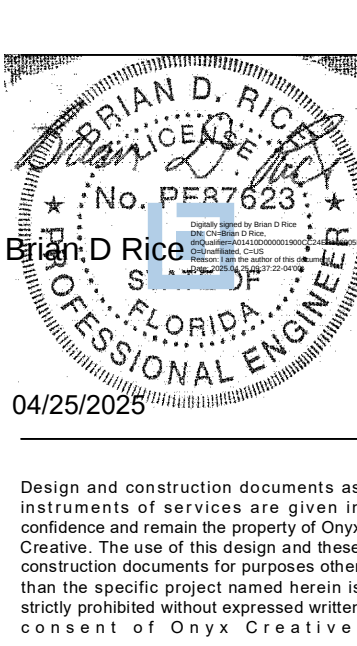
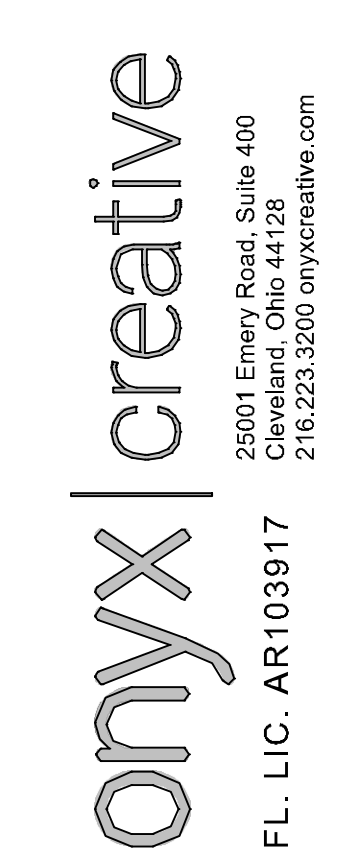
