IN THE EVENT SUCH ARCHITECT OR ENGINEER IS NOT AVAILABLE, THE OWNER SHALL EMPLOY IN HIS STEAD A COMPETENT PERSON OR AGENCY WHOSE QUALIFICATIONS ARE REVIEWED BY THE BUILDING OFFICIAL. THE BUILDING OFFICIAL SHALL ENSURE THAT ANY PERSON CONDUCTING PLANS REVIEW IS QUALIFIED AS A PLANS EXAMINER UNDER PART XII OF CHAPTER468, FLORIDA STATUTES, AND THAT ANY PERSON CONDUCTING INSPECTIONS IS QUALIFIED AS A BUILDING INSPECTOR UNDER PART XII OF CHAPTER468, FLORIDA STATUTES.
