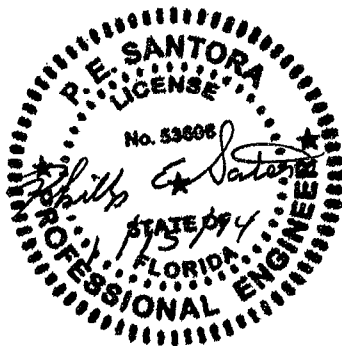
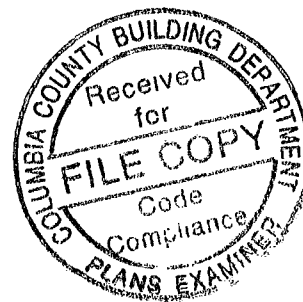
Dear Mr. Denson:


