This claim is known as a construction lien. If your contractor fails to pay subcontractors or material suppliers or neglects to make other legally required payments, the people who are owed money may look to your property for payment, even if you have pair your contractor in full. This means if a lien is filed against your property, it could be sold against your will to pay for labor, materials or
