

BEGIN at the Southeast corner of the NW 1/4 of the NE 1/4 of Section 1, Township 3 South, Range 16 East, Columbia County, Florida, and run thence South 89°08'30" West along the South line of said NW 1/4 of the NE 1/4, 344.64 feet to the center line of a paved road; thence run North 0°35'30" East along said center line, 568.89 feet to the intersection of the center line of Rivers Road; thence run South 77°58' East along said center line, 343.28 feet to the East line of said NW 1/4 of the NE 1/4; thence run South 0°20'30" East along said East line, 492.25 feet to the POINT OF BEGINNING. Said lands being a part of the SE 1/4 of the NW 1/4 of the NE 1/4, Section 1, Township 3 South, Range 16 East.
