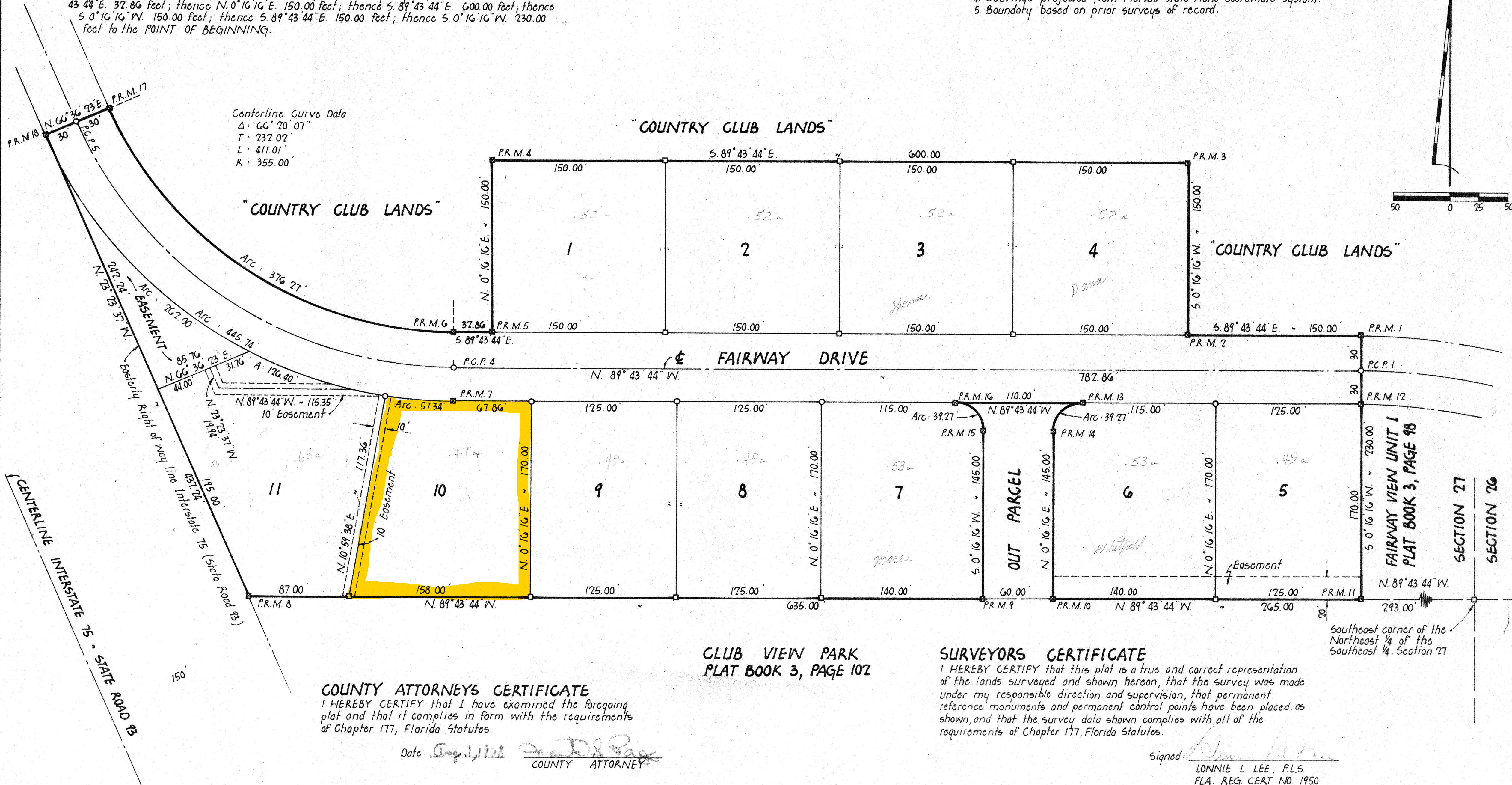

DESCRIPTION

Commence at the Southeast corner of the Northeast 1/4 of the Southeast 1/4, Section 27, Township 3 South, Range 16 East, Columbia County, Florida and run N. 89° 43' 44" W. along the South line of said Northeast 1/4 of the Southeast 1/4 a distance of 293.00 feet to the POINT OF BEGINNING; thence continue N. 89° 43' 44" along said South line 265.00 feet; thence N. 0° 16' 16" E. 145.00 feet to the point of curve of a curve concave to the right having a radius of 25.00 feet and a total central angle of 90° 00' 00"; thence Northeasterly along the arc of said curve 39.27 feet to the point of tangency of said curve; thence N. 89° 43' 44" W. 110.00 feet to the point of curve of a curve concave to the right having a radius of 25.00 feet and a total central angle of 90° 00' 00"; thence Southeasterly along the arc of said curve 39.27 feet to the point of tangency of said curve; thence S. 0° 16' 16" W. 145.00 feet to said South line of the Northeast 1/4 of the Southeast 1/4, Section 27; thence N. 89° 43' 44" W. along said South line 635.00 feet to the Easterly right of way line of Interstate 75 (State Road 93); thence N. 23° 23' 37" W. along said Easterly right of way line 437.24 feet; thence N. 66° 36' 23" E. 60.00 feet to the point of curve of a curve concave to the left having a radius of 325.00 feet and a total central angle of 66° 20' 07"; thence Southeasterly along the arc of said curve 376.27 feet to the point of tangency of said curve; thence S. 89° 43' 44" E. 32.86 feet; thence N. 0° 16' 16" E. 150.00 feet; thence S. 89° 43' 44" E. 600.00 feet; thence S. 0° 16' 16" W. 150.00 feet; thence S. 89° 43' 44" E. 150.00 feet; thence S. 0° 16' 16" W. 230.00 feet to the POINT OF BEGINNING.
