This Contract is made and entered into this date of 06/19/2025 by and between FHIA LLC, a Delaware Limited Liability Company known as ("Contractor" or "FHIA, LLC") Florida LIC: CGC1519922, and Claudia Whitt ("Owner") for certain Work on the property located at 283 SW GENT GLEN Lake City FL 32024 ("Property").

Scope of Work: The Contractor agrees to perform the work described on Exhibit "B" at the Property ("Work").

Contract Sum: Owner shall pay Contractor the sum of \$19,000 for the Work, subject to changes as set forth herein, as follows:

Deposit: Owner shall pay Contractor a Deposit in an amount equal to Thirty (30%) Percent of the Contract Sum upon the date of this Contract.

Interim Payment: Owner shall pay Contractor a Deposit in an amount equal to Thirty (30%) Percent of the Contract Sum upon the commencement of installation.

Final Payment: Owner shall pay Contractor the Final Payment, in an amount equal to Forty (40%) Percent of the Contract Sum upon Substantial Completion of the Work.

Owner hereby agrees that, pursuant to §489.126(2)(a), Florida Statutes, Contractor shall not be liable, nor required to return any Deposit paid, should the acquisition of permits exceed Thirty (30) days or the commencement of construction exceed Ninety (90) days.

EXHIBIT "A"

**DISCLOSURE REGARDING MANDATORY PROVISIONS FOR DIRECT CONTRACTS**

Pursuant to § 713.015, Florida Statutes, the following notice provision is required to be provided to the Owner (Owner) and printed in no less than 12-point, capitalized, boldface type on the front page of the contract or on a separate page, signed by the Owner (Owner) and dated. The following is provided in compliance with this requirement:

**ACCORDING TO FLORIDA'S CONSTRUCTION LIEN LAW (SECTIONS 713.001-713.37, FLORIDA STATUTES), THOSE WHO WORK ON YOUR PROPERTY OR PROVIDE MATERIALS AND ARE NOT PAID IN FULL HAVE A RIGHT TO ENFORCE THEIR CLAIM FOR PAYMENT AGAINST YOUR PROPERTY. THIS CLAIM IS KNOWN AS A CONSTRUCTION LIEN. IF YOUR CONTRACTOR OR A SUBCONTRACTOR FAILS TO PAY SUBCONTRACTORS, SUB-SUBCONTRACTORS, OR MATERIAL SUPPLIERS, THOSE PEOPLE WHO ARE OWED MONEY MAY LOOK TO YOUR PROPERTY FOR PAYMENT, EVEN IF YOU HAVE ALREADY PAID YOUR CONTRACTOR IN FULL. IF YOU FAIL TO PAY YOUR CONTRACTOR, YOUR CONTRACTOR MAY ALSO HAVE A LIEN ON YOUR PROPERTY. THIS MEANS IF A LIEN IS FILED YOUR PROPERTY COULD BE SOLD AGAINST YOUR WILL TO PAY FOR LABOR, MATERIALS, OR OTHER SERVICES THAT YOUR CONTRACTOR OR A SUBCONTRACTOR MAY HAVE FAILED TO PAY. TO PROTECT YOURSELF, YOU SHOULD STIPULATE IN THIS CONTRACT THAT BEFORE ANY PAYMENT IS MADE, YOUR CONTRACTOR IS REQUIRED TO PROVIDE YOU WITH A WRITTEN RELEASE OF LIEN FROM ANY PERSON OR COMPANY THAT HAS PROVIDED TO YOU A "NOTICE TO OWNER." FLORIDA'S CONSTRUCTION LIEN LAW IS COMPLEX AND IT IS RECOMMENDED THAT YOU CONSULT AN ATTORNEY.**
