Good afternoon, Stuart. I've attached the mapping of the wetlands for the Depree parcel that the county uses for permitting purposes. The wetland overlay that we use is from the Nation Wetland Inventory site. We have received the Zero Rise certificate, Profile view for BFE and the SRWMD permit, but SRWMD does not include wetlands. We will need the Wetlands delineated by a geologist/survey. This may allow for the proposed site to remain as requested. On the Profile view, the existing grade elevation is substantially higher than our Lidar elevation

On the Profile view, the existing grade elevation is substantially higher than our Lidar elevation markers. Please recheck the existing ground elevations. Please also provide a Plan-Based Elevation Certificate for this project.

And on a final note the electrical meter will be elevated and may, in its current shown location, require exterior stair access for the power company.
