ENHANCED LIFE ESTATE DEED

THIS WARRANTY DEED made this 10 day of February, 2026 by **Larry W. Bridges and Paulette N. Bridges, Husband and Wife**, whose post office address is 135 NW Olive Gln, Lake City, FL 32055, of the County of Columbia, State of Florida, hereinafter called the Grantor, to **Larry W. Bridges and Paulette N. Bridges, Husband and Wife**, whose post office address is 135 NW Olive Gln, Lake City, FL 32055, of the County of Columbia, State of Florida, conveying the property herein described for a Life Estate, without any liability for waste, and with full power and authority in the life of the tenant to sell, convey, mortgage, lease or otherwise manage and dispose of the property described herein, in fee simple, with or without consideration, without joinder of the remainderman, and with full power and authority to retain any and all proceeds generated thereby, and upon the death of the life tenant, the remainder, if any, to **Betsy Roberts** (Wherever used herein the terms "grantor" and "grantee" include all the parties to this instrument and the heirs, legal representatives and assigns of individuals, and the successors and assigns of corporations).

WITNESSETH: That the grantor, for and in consideration of the sum of TEN AND 00/100'S (\$10.00) Dollars, and other variable considerations, receipt whereof is hereby acknowledged, hereby grants, bargains, sells, aliens, remises, releases, conveys and confirms unto the grantee, all that certain land situated in COLUMBIA County, Florida, viz:

*DESCRIPTION PARCEL A:
COMMENCE AT THE SW CORNER OF THE NW 1/4 OF SECTION 5, TOWNSHIP 3 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLORIDA, AND RUN THENCE N.88°52'00"E., ALONG THE SOUTH LINE OF SAID NW 1/4, 1169.72 FEET; THENCE N.12°14'20"E., 205.58 FEET; THENCE N.88°49'50"E., 206.14 FEET; THENCE N.12°14'29"E., 267.27 FEET TO A POINT ON THE NORTH RIGHT-OF-WAY LINE OF NW OLIVE GLEN; THENCE CONTINUE N.12°14'29"E., 321.12 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE N.12°14'29"E., 327.48 FEET TO A POINT ON THE SOUTH RIGHT-OF-WAY LINE OF NW IVY GLEN; THENCE N.88°52'00"E., ALONG SAID SOUTH RIGHT-OF-WAY LINE 217.80 FEET TO ITS INTERSECTION WITH THE WEST RIGHT-OF-WAY LINE OF U.S. HIGHWAY #441; THENCE S.12°14'29"W., ALONG SAID WEST RIGHT-OF-WAY LINE 327.48 FEET; THENCE S.88°52'00"W., 217.80 FEET TO THE POINT OF BEGINNING. CONTAINING 1.59 ACRES MORE OR LESS.*

NOTE: The Grantor specifically reserves the right (i) to revoke the remainder interest hereunder and divest the remainderman and re-vest the life tenant with fee simple title without joinder of the remainderman, or (ii) to convey the remainder interest created hereunder to another remainderman; all without joinder of the remainderman established under this deed.

SUBJECT TO restrictions, reservations, easements and limitations of record, if any, provided that this shall not serve to reimpose same, zoning ordinances, and taxes for the current year and subsequent years.


TOGETHER with all the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.







