As requested, I inspected the building site for the proposed construction at the above referenced site. The construction of the building pad for the home was partially complete. Both photos were taken from NW Country Lake drive: Photo I looking west and Photo 2 looking south.





Based on the LIDAR on the Columbia County website, the existing road centerline elevation varies from 140.3+/- to 139.9+/- and the existing ground at the building site is 137.3+/-. The approximate ground elevation at the edge of the floodplain is 133.8+/-. The minimum finished floor of the home shall be 139.40. The finished floor of the home will be below the required elevation of one foot above the adjacent road. The topography of the site drains to



the back of the property to an existing wetland and floodplain. The home will be located in zone X.

I certify that the minimum finished floor elevation listed above will protect the structure against water damage from a base flood event, as defined in Article 8 of the Land Development Regulations.





PERCENT CHANCE OF FLOODING OVER 30 YEAR PERIOD







AE, A1-A30

AΗ

Areas with a 1% annual chance of flooding and a 26% chance of flooding over the life of a 30-year mortgage. Usually areas of ponding with flood depths of 1 to 3 feet. Base Flood Elevations are determined.

AO

Areas with a 1% annual chance of flooding and a 26% chance of flooding over the life of a 30-year mortgage. Usually areas of sheet flow on sloping terrain with flood depths of 1 to 3 feet.Base Flood Elevations are determined.

Supplemental Information:

10%-chance flood elevations (10-year flood-risk elevations) and 50%-chance flood elevations (2-year flood-risk elevations), are calculated during detailed flooding studies but are not shown on FEMA Digital Flood Insurance Rate Maps (FIRMs). AE FW (FLOODWAYS)

X 0.2 PCT (X Shaded, 0.2 PCT ANNUAL CHANCE FLOOD HAZARD)

Same as Zone X; however, detailed studies have been performed, and the area has been determined to be within the 0.2 percent annual chance floodplain (also known as the 500-year flood zone). Insurance purchase is not required in this zone but is available at a reduced rate and is recommended.

Χ

All areas outside the 1-percent annual chance floodplain are Zone X. This includes areas of 1% annual chance sheet flow flooding where average depths are less than 1 foot, areas of 1% annual chance stream flooding where the contributing drainage area is less than 1 square mile, or areas protected from the 1% annual chance flood by levees. No Base Flood Elevations or depths are shown within this zone. Insurance purchase is not required in these zones.
