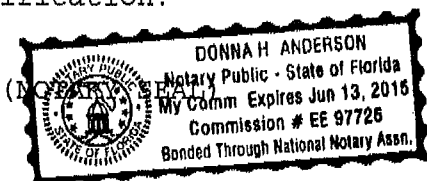

SCHEDULE "A" TO NOTICE OF COMMENCEMENT
