

DELEGATION OF SIGNING AUTHORITY FOR CELL SITE (MACRO) LEASES (ANCILLARY AGREEMENTS ONLY)

T-Mobile USA, Inc., and its subsidiaries listed in Exhibit A ("T-Mobile") are governed by various policies that restrict signing of contracts.

T-Mobile's Board of Directors approved a Delegation of Authority for the Chief Financial Officer ("CFO") to delegate signing authority on behalf of T-Mobile. The CFO approved T-Mobile's Procurement and Approval Authority Policy (the "Procurement Policy") that provides that only T-Mobile Procurement personnel can sign contracts for goods and services.

The person delegating has authority under the Procurement Policy to delegate signing authority to the person receiving authority for the types of contracts, time period, T-Mobile entities, and for the time period listed below:

Delegated Signing Authority:	The ancillary agreements and documents listed in Exhibit A
Delegated Personnel:	Manager, Engineering Development
Total Committed Value (e.g., all T-Mobile required payments) may not exceed:	\$0.00 (Delegate has no spend authority)
Expiration of Signing Authority:	The earlier of a change in the T-Mobile Procurement Policy that is in effect as of the date of last signature below, or a change of Delegate's title.
T-Mobile Entities Authorized:	See Exhibit B

It is the responsibility of the person delegating authority and the person accepting delegation to ensure compliance with all T-Mobile policies.

This Delegation of Signing Authority may be revoked at any time by T-Mobile's CFO or CPO (Chief Procurement Officer).



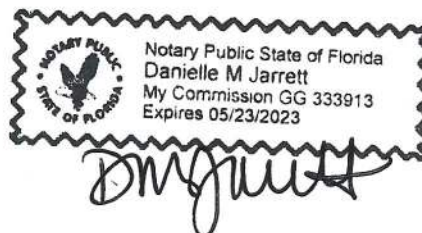
