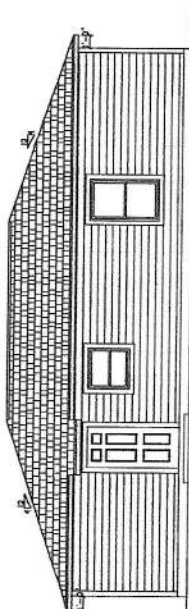
ROOF PLAN

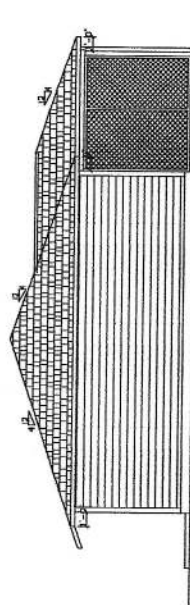
WALL/FOUNDATION SECTION
SCALE 1/2" = 1'-0"



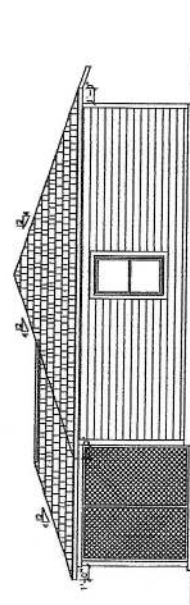
FRONT ELEVATION
