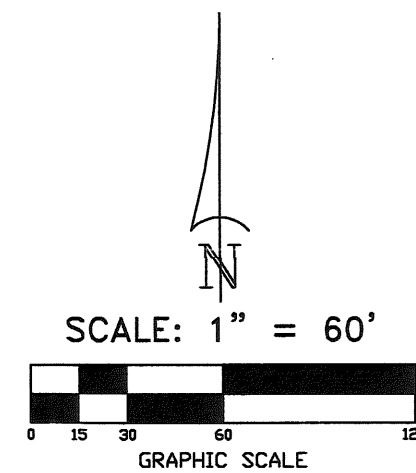


A BOUNDARY SURVEY IN SECTION 18, TOWNSHIP 7 SOUTH,

DESCRIPTION:  
COMMENCE AT THE SE CORNER OF THE NE 1/4 OF THE NW 1/4 OF THE NW 1/4 OF SECTION 18, TOWNSHIP 7 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLORIDA AND RUN THENCE S.87°57'21"W., ALONG THE SOUTH LINE OF SAID NE 1/4 OF NW 1/4 OF NW 1/4, 283.26 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE S.87°57'21"W., ALONG SAID SOUTH LINE 300.69 FEET; THENCE N.01°24'45"W., 551.51 FEET, TO A POINT ON THE SOUTHERLY RIGHT-OF-WAY LINE OF COUNTY ROAD NO. 778; THENCE N.75°26'15"E., ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE 27.34 FEET TO A POINT OF A CURVE ON SAID SOUTHERLY RIGHT-OF-WAY LINE, SAID CURVE BEING CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 2824.79 FEET AND AN INTERNAL ANGLE OF 05°39'17"; THENCE RUN NORTHEASTERLY ALONG THE ARC OF SAID SOUTH RIGHT-OF-WAY LINE AN ARC DISTANCE OF 278.79 FEET, SAID CURVE BEING SUBTENDED BY A CHORD BEARING AND DISTANCE OF N.78°15'54"E., 278.68 FEET; THENCE S.01°23'52"W., 604.26 FEET TO THE POINT OF BEGINNING, CONTAINING 4.01 ACRES MORE OR LESS.

  - BEARINGS ARE BASED ON A DEED BEARING OF S.87°57'21"W., FOR SOUTH LINE OF NE 1/4 OF NW 1/4 OF NW 1/4.

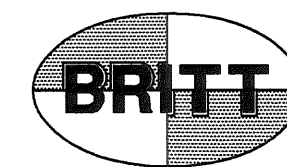
