- Provide permits as required.
- Provide necessary supervision.
- Provide dumpster and debris disposal.

- Remove existing wall mounted water fountain and cap off.

- Brick walls in hall will have drywall fasten directly to the brick with trim around doors as required.
- Open up existing opening between hall and front office.
- Prep and paint new walls to match existing interior building color scheme, prep and paint doors & frames in hall area.
- Install two Lever Locks on hallway doors.

- Prep, prime and paint new door and frame.
- Prep, prime and paint new walls and paint one existing wall.
- Prep, prime and paint existing floor with porch and deck enamel.

Main Office Exterior

- Prep, prime, and finish paint new siding and trim to match existing building color scheme, as near as possible.
- IT & electrical on Southwest corner of building to be moved, disconnected and reconnected by City's IT personnel.
- Provide supervision as required.
- Provide proper debris disposal.
- Provide permits as required.

Main Office Interior

- Remove existing acoustical grid and tile ceiling in front office, hall, and Northwest office.
- Remove existing wall paneling from above noted offices.
- Remove existing wall mounted water fountain and cap off.
- · Remove existing carpet in the offices noted above.
- Install furring and/or framing as need and install new drywall with finish.
- Brick walls in hall will have drywall fasten directly to the brick with trim around doors as required.
- · Open up existing opening between hall and front office.
- Relocate existing A/C exposed duct as required for better efficiency.
- Install new 2'x2'x5/8" Armstrong Fine Fissured square edge, #1728 ceilings panels in an exposed white 15/16" grid system with R19 insulation install above the acoustical ceilings.

- Install 8 new 2'x4' Troffer LED lighting in the two offices and hall.
- Install LVP and 4" vinyl baseboard in three offices.
- Prep and paint new walls to match existing interior building color scheme, prep and paint doors & frames in hall area.
- Install two Lever Locks on hallway doors.
- Provide supervision as required.
- Provide proper debris disposal.
- Provide permits as required.

Maintenance Office Remodel

- Remove acoustical grid & tile ceiling and lights & conduit as necessary.

- Install Hardie Board type paneling to match the paneling we installed on the East wall.

- Prep, prime and paint existing floor with porch and deck enamel.
- Install new 2'x2'x5/8" Armstrong Fine Fissured square edge, #1728 ceilings panels in an exposed white 15/16" grid system with R19 insulation install above the acoustical ceilings.
- Install 4 new 2'x4' Troffer LED lighting.
- · Provide supervision as required.
- · Provide proper debris disposal.
- Provide permits as required.

- 2. Any rotten wood discovered behind the current siding would be and extra.
