As requested, I inspected the building site for the proposed construction at the above referenced site. The home was constructed. The topography of the site drains to the north. The attached flood report shows a flood zone on the north end of the property. The home is located in zone X per the attached site plan by others.





Per the attached flood report, the BFE is 106.7'. The approximate existing ground elevation of the building site is 124' +/-. The minimum finished floor elevation shall be 1' above the adjacent ground for the entire perimeter of the foundation. The finished floor elevation will be below the required 1' above the adjacent road; however, it is sufficient to protect the home from water damage in a base flood event.
