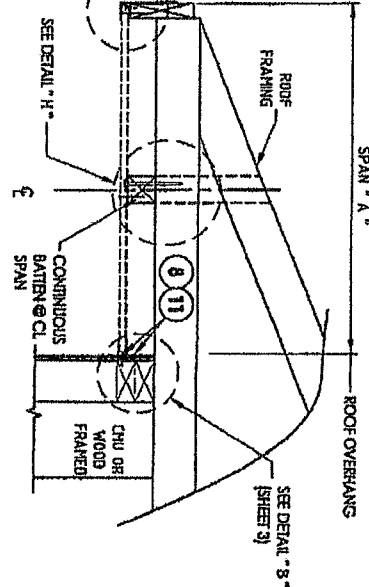
SIDE VIEW - DOUBLE SPAN W/ BATTEN
