- 2. (Refer to picture 1.21) Scupper trim installation to be completed once built.

 Add collector heads and downpours then seal. Add splash blocks to protect the membrane surface.

Owner maintenance items noted:

- Through wall scuppers should be cleaned periodically to allow for proper drainage.




