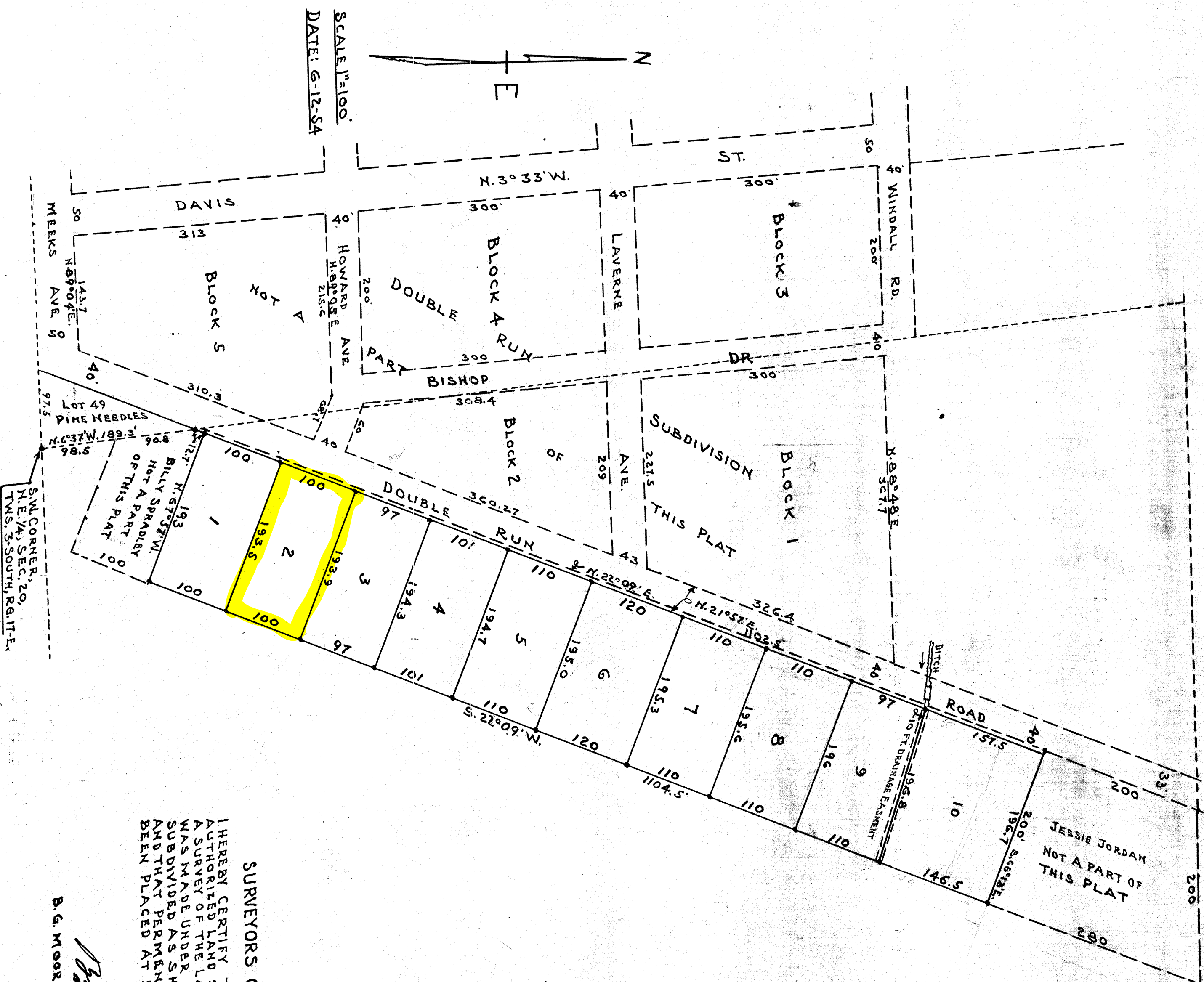


VILLA GRANADA

DESCRIPTION

COMMENCE AT THE S.W. CORNER OF SAID S.W. 1/4 OF N.E. 1/4 AND RUN N. 63° 37' W. 189.3 FT. THENCE N. 21° 57' E. 121.1 FT. TO A POINT OF BEGINNING AND RUN THENCE N. 62° 32' W. 171 FT. THENCE N. 22° 08' E. 1102.5 FT. THENCE S. 68° 43' E. 200 FT. THENCE S. 22° 08' W. 1104.5 FT. THENCE N. 67° 57' W. 193.0 FT. TO POINT OF BEGINNING.
