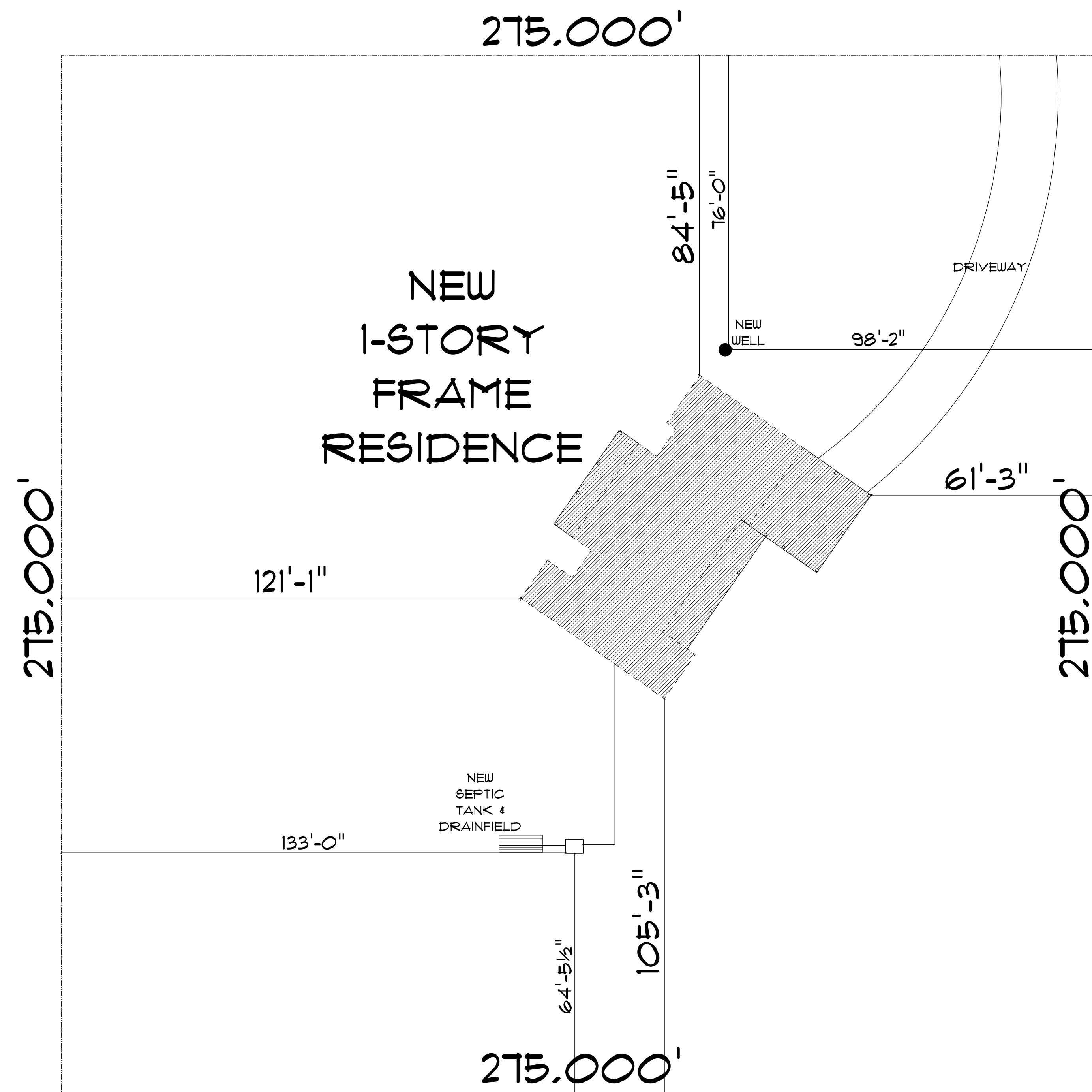
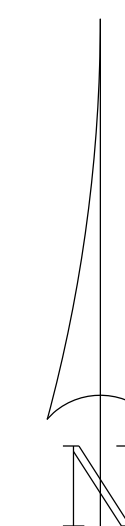




* SITE PLAN *

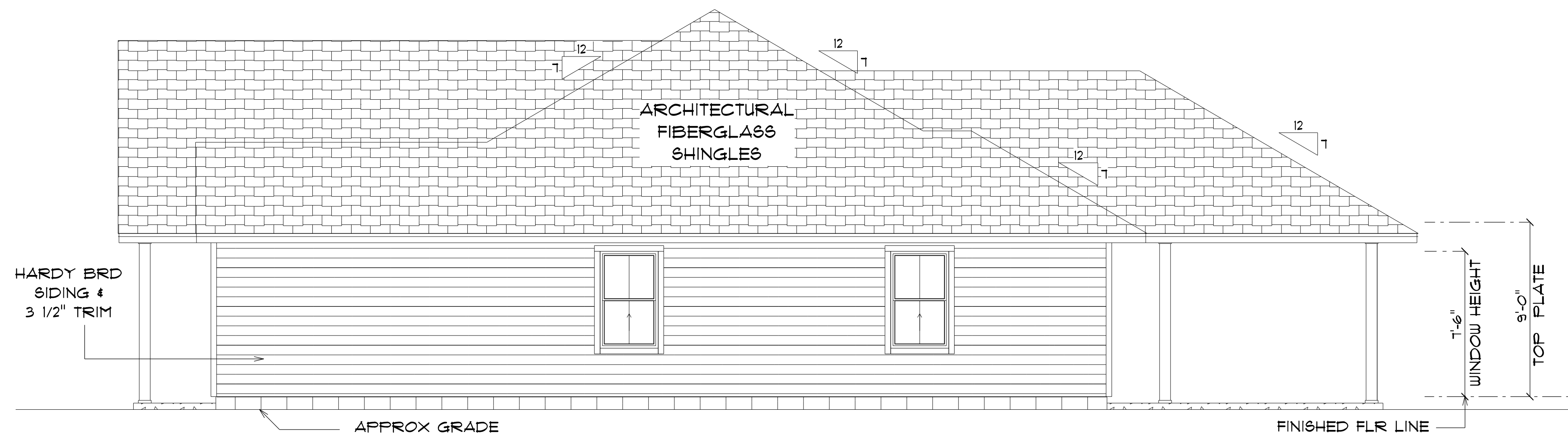

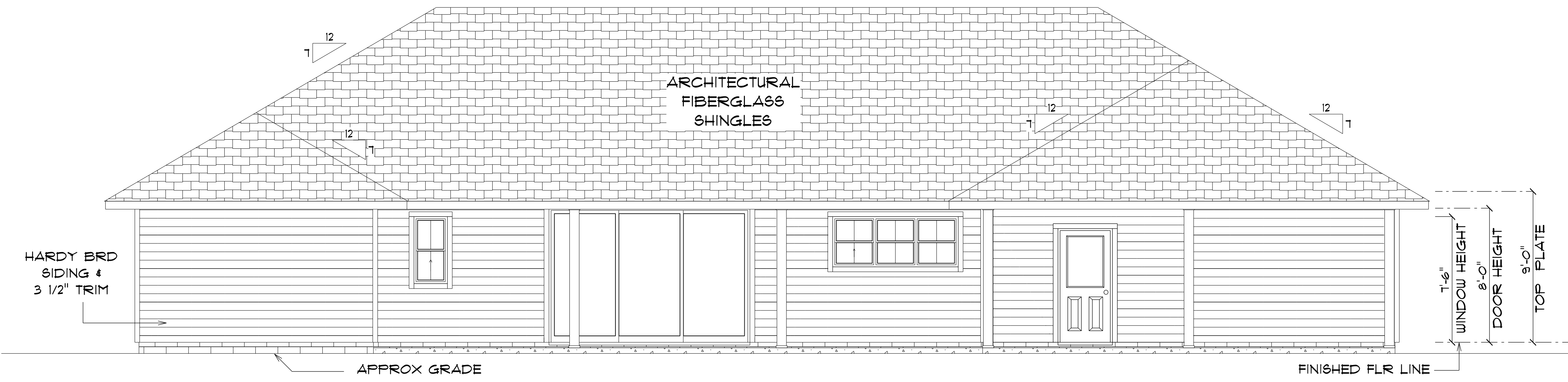
