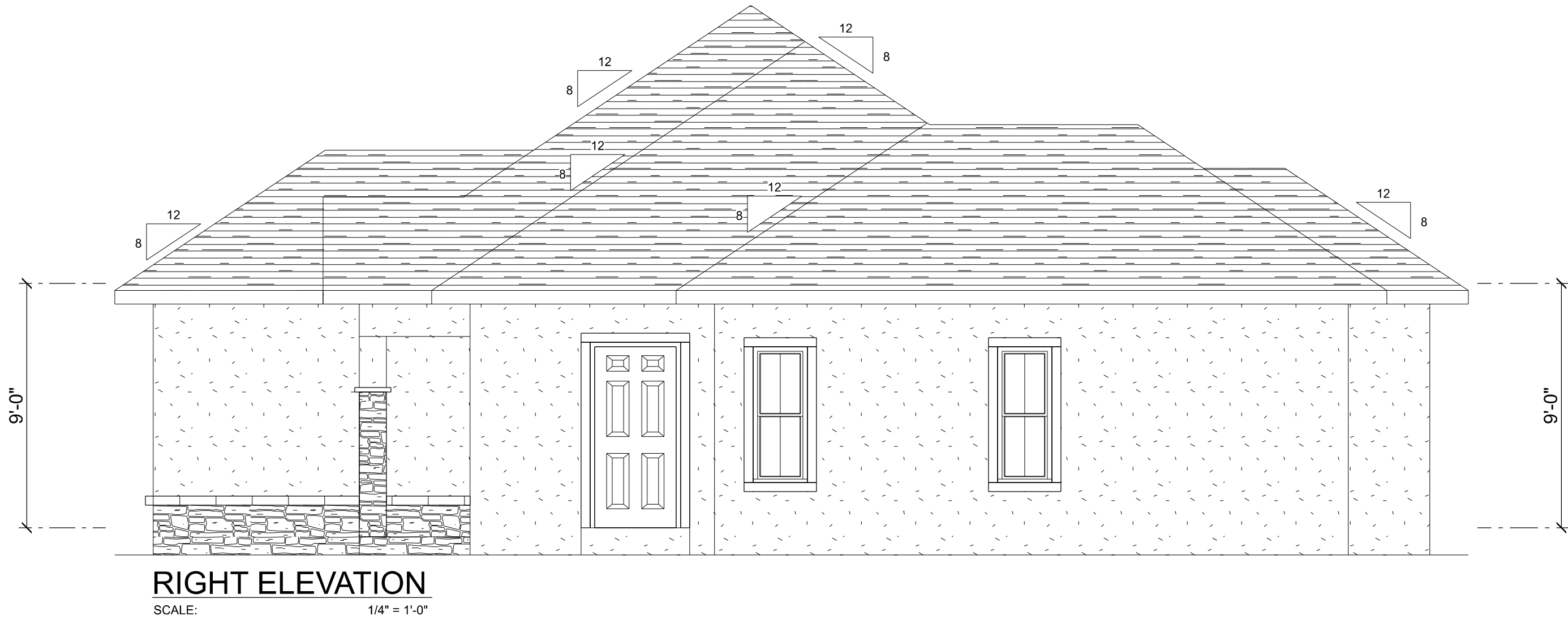

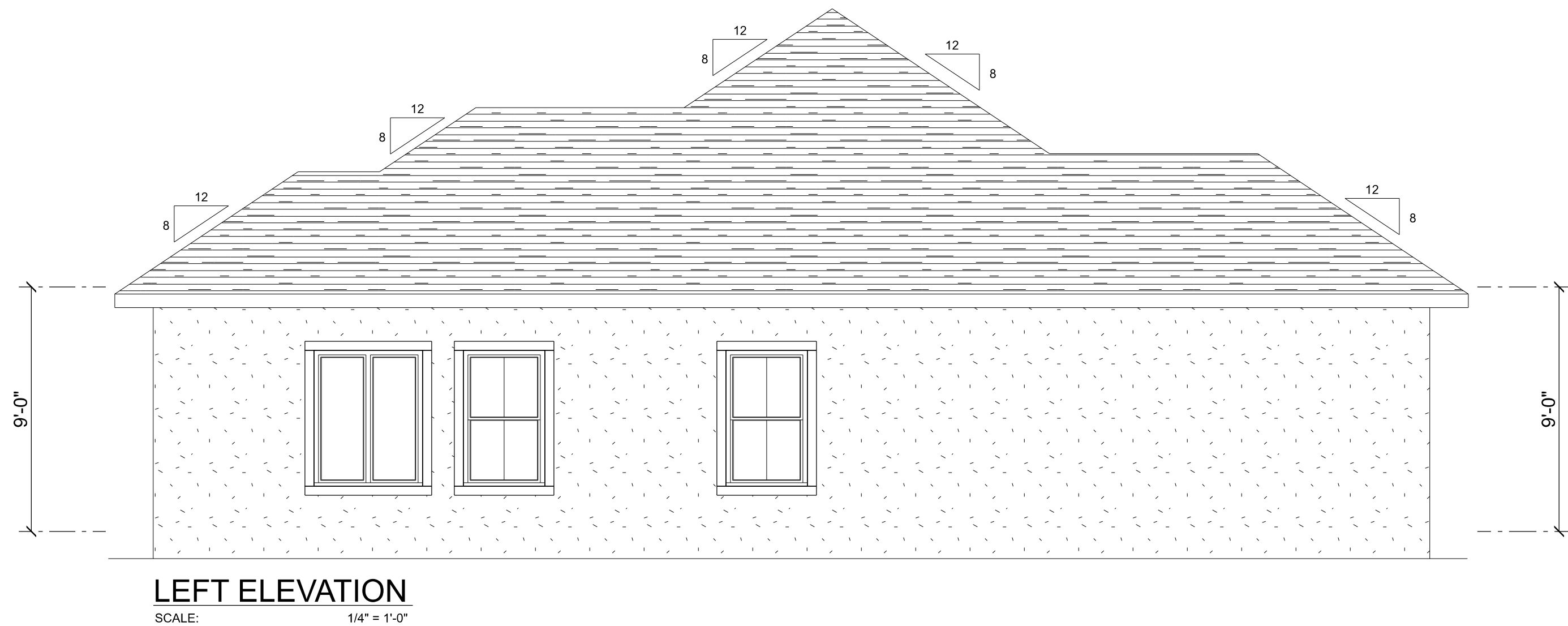

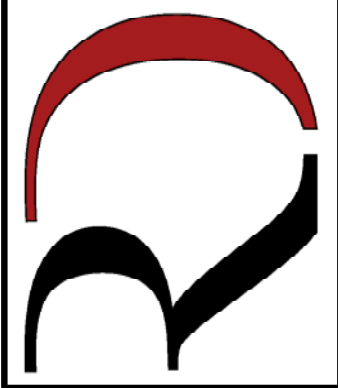
RIGHT ELEVATION

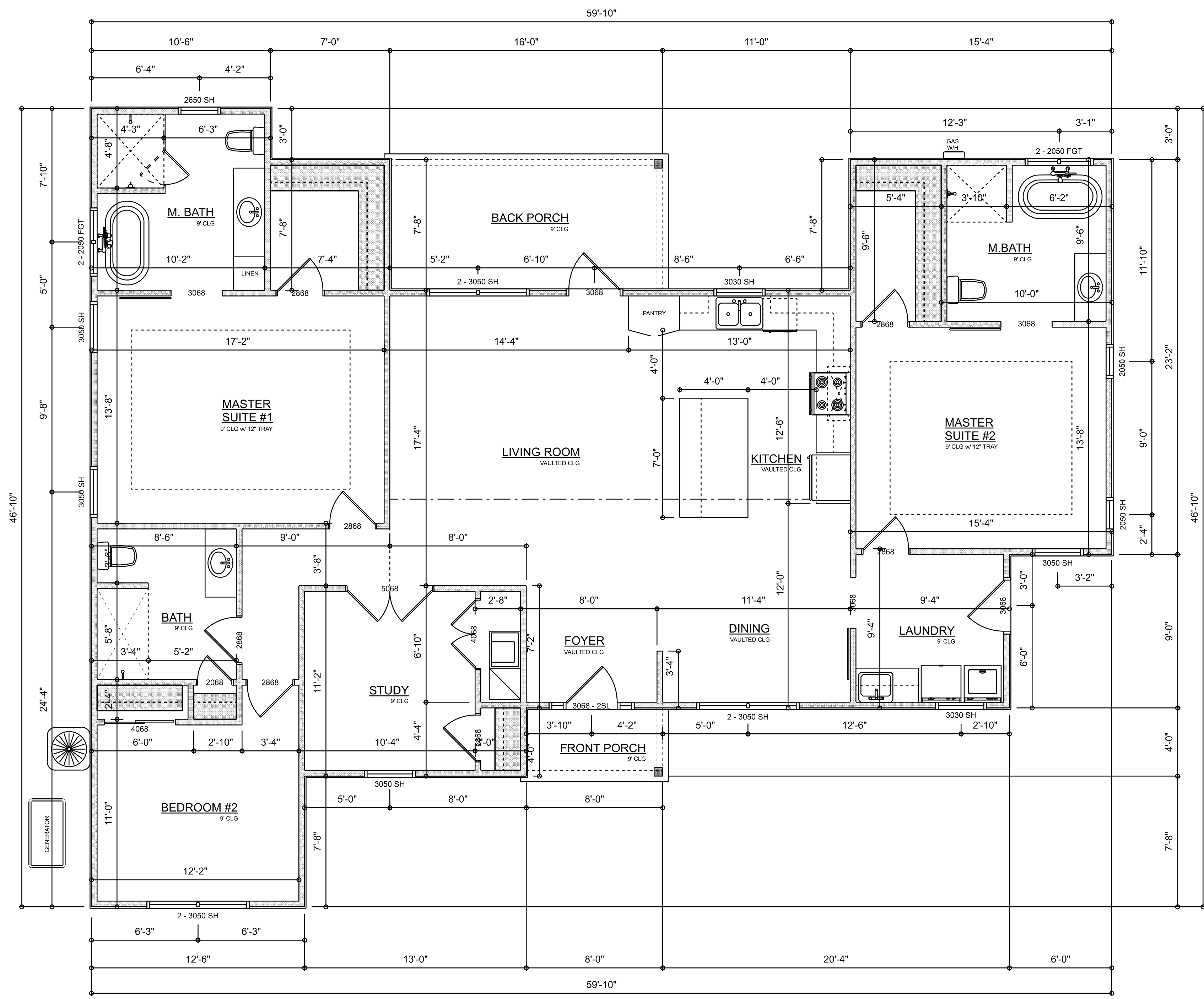
