**The South 1/2 of the Southwest 1/4 of the Southwest 1/4 of Section 24, Township 5 South, Range 15 East, Columbia County, Florida.**

**LESS AND EXCEPT** A portion of the South 1/2 of the Southwest 1/4 of the Southwest 1/4 of Section 24, Township 5 South, Range 15 East, Columbia County, Florida, being more particularly described as follows:

**Begin at the Southeast corner of the Southwest 1/4 of the Southwest 1/4 of said Section 24, and run North 00°05'06" East, along the East line of said Southwest 1/4 of the Southwest 1/4, a distance of 208.71 feet; thence South 89°58'14" West parallel with the South line of said Southwest 1/4 of the Southwest 1/4 a distance of 208.71 feet; thence South 00°05'06" West parallel with the East line of said Southwest 1/4 a distance of 208.71 feet; thence North 89°58'14" East along the South line of said Southwest 1/4 of the Southwest 1/4 a distance of 208.71 feet to the Point of Beginning.**
