It appears that you may be eligible for USDA Assistance to remove the following Health and Safety items; Per my visit of February 13, 2007.

1. Back 1/2 of dwelling needs a new roof. Remove old roof, install new 15 lb felt and 20 year singles.
2. Install new septic system, complete with new drain lines. System must be hooked to existing plumbing.
- * 3. Upgrade Electrical box to 200 amp service.
4. Front bedroom ceiling has not drywall. Install new drywall and finish.
5. Add attic insulation to a R-30 value.
- * 6. Install electrical and plumbing for Dryer and washer in front room.

All of the above work must be bid on by licensed building contractors and must be performed in accordance with local and state building codes.

Please request quotes on the above work from several contractors and submit to us for review. Once we have reviewed and determined the bids are acceptable, we will determine the availability of funds and hopefully can assist you in making the needed repairs. 


