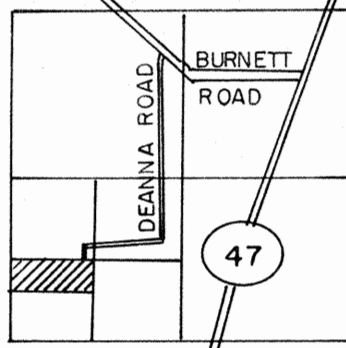


"COUNTRY LANDINGS"

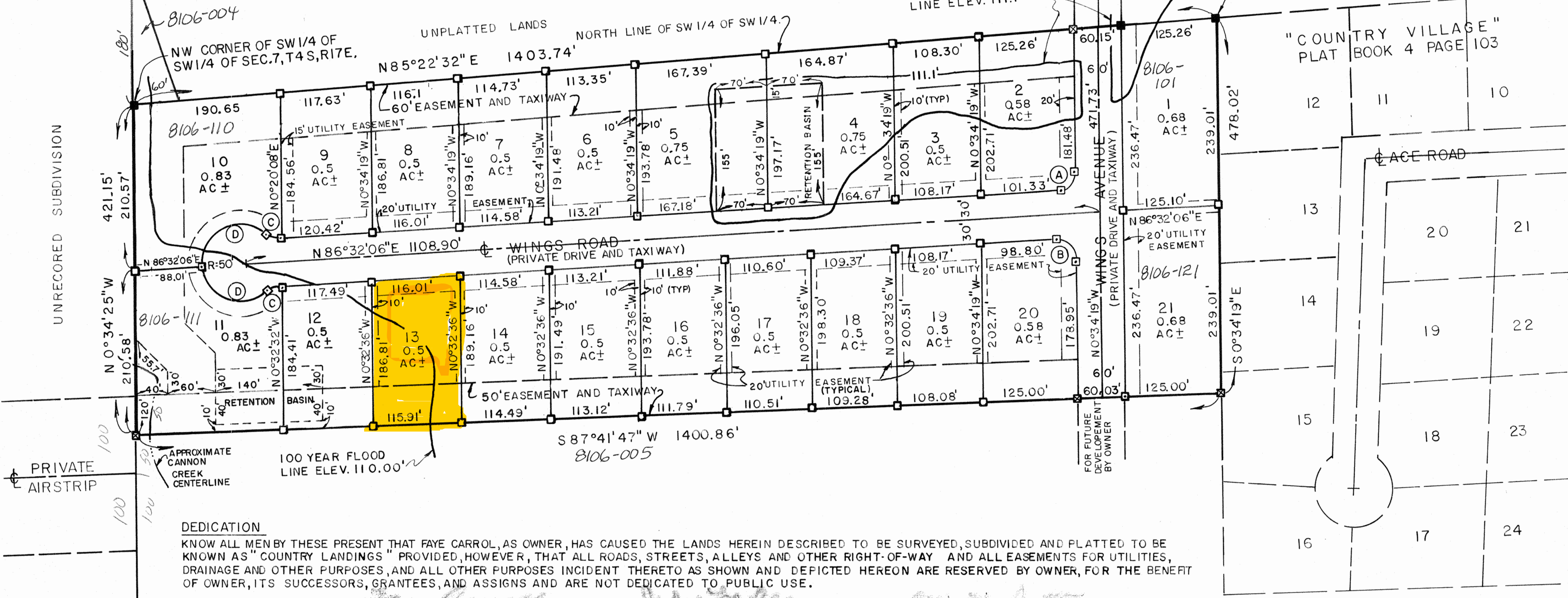

DESCRIPTION:
A PART OF THE NORTH 1/2 OF THE SW 1/4 OF SECTION 7, TOWNSHIP 4 SOUTH, RANGE 17 EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGIN AT THE NW CORNER OF LOT 12 OF "COUNTRY VILLAGE" AS PER PLAT THEREOF RECORDED IN PLAT BOOK 4, PAGE 103 OF THE PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA, AND RUN S 0°34'19" E, ALONG THE WEST LINE OF SAID "COUNTRY VILLAGE", 478.02 FEET; THENCE S 87°41'47" W, 1400.86 FEET; THENCE N 0°34'25" W, 421.15 FEET TO THE NW CORNER OF SAID SW 1/4 OF THE SW 1/4; THENCE N 85°22'32" E, ALONG THE NORTH LINE THEREOF, 1403.74 FEET TO THE POINT OF BEGINNING, COLUMBIA COUNTY, FLORIDA, CONTAINING 14.45 ACRES, MORE OR LESS.

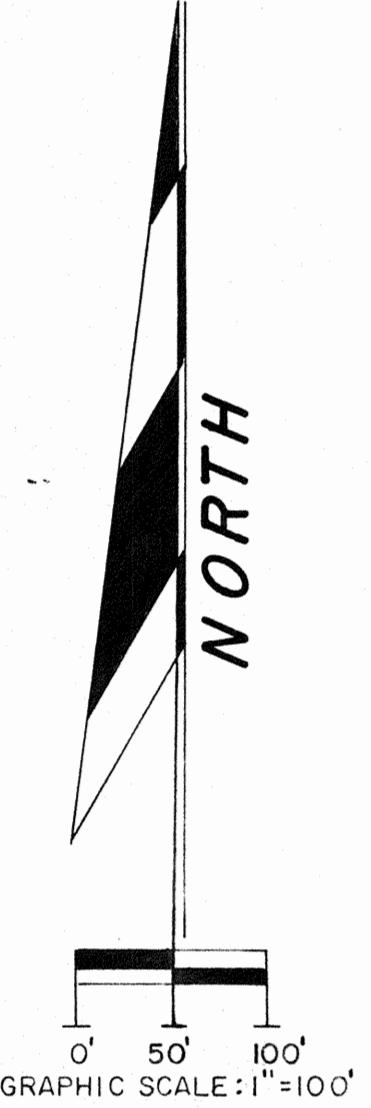

1. PRELIMINARY PLAN APPROVED 18 JULY 1991.
2. CLOSURE IS 1:1,481,500.
3. THERE MAY BE ADDITIONAL RESTRICTIONS THAT ARE NOT RECORDED ON THIS PLAT THAT MAY BE FOUND IN THE PUBLIC RECORDS OF THIS COUNTY.
4. BEARINGS BASED ON SECTIONAL BREAKDOWN BY THIS OFFICE.
5. THIS PARCEL IS IN ZONE 'A' AND 'X'. ZONE 'A' IS SUBJECT TO FLOODING ZONE 'X' IS DETERMINED TO BE OUTSIDE THE 500 YEAR FLOOD PLAIN AS PER FLOOD INSURANCE RATE MAP, DATED 6 JAN 1988, COMMUNITY PANEL NO. 120070 0175 B.
6. THE STREETS, EASEMENTS, DRAINAGE, IMPROVEMENTS AND COMMON AREAS, IF ANY, ARE NOT DEDICATED TO THE PUBLIC AND WILL NOT BE MAINTAINED, REPAIRED OR IMPROVED BY COLUMBIA COUNTY, FLORIDA. EACH LOT WITHIN THIS SUBDIVISION SHALL BE REQUIRED TO PAY ASSESSMENTS TO A HOMEOWNERS ASSOCIATION FOR MAINTENANCE OF SUCH IMPROVEMENTS.
7. ALL UTILITY EASEMENTS SHOWN ON THIS PLAT SHALL BE FOR THE CONSTRUCTION, INSTALLATION, MAINTENANCE, AND THE OPERATION OF ELECTRIC, TELEPHONE, GAS, CABLE T.V., AND ANY OTHER PUBLIC UTILITIES.
8. FLOOD ELEVATION IS DETERMINED BY ARTHUR BEDENBAUGH, P.E. NO. 9162.
9. THE LOWEST STRUCTURAL MEMBER OF THE FIRST FLOOR OF HABITABLE BUILDINGS SHOULD BE AT LEAST ONE FOOT ABOVE THE 100 YEAR FLOOD ELEVATION.
10. NON HABITABLE BUILDINGS BUILT BELOW THE 100 YEAR FLOOD ELEVATION MAY BE SUBJECT TO PERIODIC FLOODING.

11. THE HIGH WATER ELEVATION ON THE NORTH SIDE OF SUBDIVISION IS BASED ON THE LOW AREAS OF LOTS 2, 3 & 4 BEING FILLED AND ALL WATER BEING CONTAINED WITHIN THE DRAINAGE EASEMENT. THE BOUNDARY OF THE HIGH WATER IS BASED ON THE LOTS NOT BEING FILLED AND IN THIS EVENT THE HIGH WATER ELEVATION WOULD BE LOWER DUE TO THE INCREASED STORAGE AREA.
