Install min, 32' x 18" corr metal culvert w /  
concrete mitred ends, w / 6" x 6" welded wire,  
rebar or culvert bolts in mitred ends, concrete  
mitred ends W -3ft x L -4ft, with 4" of limerock on  
top, culvert must be 5 ft from crossover culvert, do  
not block crossover culvert.

**Notice:** in addition to the requirements of this permit, there may be additional restrictions applicable to this property that may be found in the public records of this county. The issuance of this permit does not waive compliance by permittee with deed restrictions.

**Notice:** all other applicable state or federal permits shall be obtained before commencement of this permitted development.

Work shall be considered not suspended, abandoned or invalid when the permit has received an approved inspection within 180 days of the previous inspection.
