



SITE PLAN EXAMPLE / WORKSHEET

## DESCRIPTION

BEGIN at the Northeast corner of the southeast 1/4 of the Northeast 1/4, Section 16, Township 4 South, Range 17 East, Columbia County, Florida; said point being also the Northwest corner of the southwest 1/4 of the Northwest 1/4, Section 15, Township 4 South, Range 17 East Columbia County, Florida and run N. 88° 50' 12" E. along the North line of said Southwest 1/4 of the Northwest 1/4, Section 15, a distance of 331.72 Feet; thence S. 29° 03' 27" E. 108.11 Feet to the point of curve of a curve concave to the right having a radius of 180.00 Feet and a total central angle of 54° 32' 53"; thence southerly along the arc of said curve 171.36 Feet to the point of tangency of said curve, thence S. 25° 29' 26" W. 92.35 Feet to the point of curve of a curve concave to the right having a radius of 199.11 Feet and a total central angle of 29° 48' 06"; thence southwestwardly along the arc of said curve 59.98 Feet to a point on the arc of a curve concave to the left having a radius of 50.00 Feet and a total central angle of 76° 39' 42"; thence southerly along the arc of said curve 66.90 Feet to the point of tangency of said curve; thence S. 33° 54' 15" E. 253.02 Feet, thence S. 1° 25' 46" E. 17.68 Feet to the South line of the North 1/2 of the Southwest 1/4 of the Northwest 1/4, Section 15, thence S. 88° 45' 44" W. along said South line of the North 1/2 of the Southwest 1/4 of the Northwest 1/4, Section 15, a distance of 435.84 Feet to the Southeast corner of the North 1/2 of the Southeast 1/4 of the Northeast 1/4, Section 16, thence S. 89° 43' 39" W. along the South line of said North 1/2 of the Southeast 1/4 of the Northeast 1/4, Section 16, a distance of 369.87 Feet; thence N. 1° 16' 23" W. 4.09 Feet, thence N. 6° 52' 02" W. 685.25 Feet to the North line of said Southeast 1/4 of the Northeast 1/4, Section 16, thence N. 89° 46' 25" E. along said North line 434.81 Feet to the POINT OF BEGINNING. Containing 12.05 Acres more or less.


