## WARRANTY DEED

(STATUTORY FORM – SECTION 689.02, F.S.)

**Witnesseth**, that said Grantor, for and in consideration of the sum of TEN DOLLARS (U.S.\$10.00) and other good and valuable considerations to said Grantor in hand paid by said Grantees, the receipt whereof is hereby acknowledged, has granted, bargained, and sold to the said Grantees, and Grantees' heirs and assigns forever, the following described land, situate, lying and being in Columbia, Florida, to-wit:

Commence at the NE corner of SW 1/4 of SW 1/4, Section 27, Township 3 South, Range 17 East, Columbia County, Florida, and run thence South 87°24'04" West, along the North line of SW 1/4 of SW 1/4, 667.85 feet; thence South 1°27'07" East, 377.73 feet to the Point of Beginning; thence South 89°21'07" East, 462.31 feet; thence South 2°04'11" East, 274.00 feet; thence North 86°26'02" West, 20 feet; thence North 2°04'11" West, 30 feet; thence North 86°26'02" West, 446.58 feet; thence North 1°27'07" West, 234.11 feet to the Point of Beginning.

AND

Commence at the SE corner of the SW 1/4 of SW 1/4, Section 27, Township 3 South, Range 17 East, Columbia County, Florida, and run North 2°10'34" West, along the East line of said SW 1/4 of SW 1/4, a distance of 613.71 feet to the Point of Beginning; thence South 86°39'17" West, and parallel to the South line of the SW 1/4 of SW 1/4, 208.71 feet; thence North 2°10'34" West, 40 feet; thence North 86°39'17" East, 208.71 feet to the East line of the said SW 1/4 of SW 1/4; thence South 2°10'34" East, along said East line 40 feet to the Point of Beginning.

Together with that certain 1975 Skyline Double Wide Mobile Home, Vehicle Identification Numbers: 20647R and 20647L, situated upon said land and considered part thereof.
