

Garage fire separations shall comply with the following:


Gardage Inter Separation's Strait Cortingly With the following:

1. The private garage shall be separated from the dwelling will and its attic area by means of a minimum %-inch (12,7 mm) gypsum board applied to the garage side. Garages beneath habitable rooms shall be separated from all habitable ones above by not less than 558-inch Type X gypsum board or equivalent. Door openings between a private garage and the dwelling unit shall be grained to the control test between the private garage and the dwelling unit shall be gypsum bore size door not dest binn 150 inches (34.9 morn bed size doors not dest) than 150 inches (34.9 morn used for sleeping purposes shall not be permitted.

2. Ducts in a private garage and ducts penetrating the walls or ceilings separating the dwelling unit from the garage shall be constructed of a minimum 0.019-inch (0.48 mm) sheet steel and shall have no openings into the garage.

 $3.\,$ A separation is not required between a Group R-3 and U carport provided the carport is entirely open on two or more sides and there are not enclosed areas above.

4. When installing an attic access and/or pull-down stair unit in the garage, devise shall have a minimum 20 min. fire rating.





ALL SMOKE DETECTORS BE A COMBO SMOKE & CARBON MONOXIDE DETECTOR AND SHALL HAVE BATTERY BACKUP POWER AND ALL VIRED TOGETHER SO IF ANY ONE UNIT IS ACTUATED THEY ALL ACTIVATE.

ALL INTERIOR & EXTERIOR LIGHTING SHALL MEET OR EXCEED THE MIN. 75% HIGH-EFFICIENCY LIGHTING PER FBC-ENERGY CONSERVATION R404.

THE ELECTRICAL SERVICE OVERCURRENT PROTECTION DEVICE SHALL BE INSTALLED ON THE EXTENDIOR OF STRUCTURES TO SERVICE AS A DISCONNECT MEANS. COMPLICTORS USED FROM THE EXTENDIOR DISCONNECTION MEANS TO A PANEL OR SUB-PANEL SHALL HAVE FOUR-WIRE CONDUCTORS, OF WHICH ONE CONDUCTOR SHALL BUT AS AN RECOMPRINT GROUND.

IT IS THE LICENSED ELECTRICAL CONTRACTORS RESPONSIBILITY TO INSURE THAT ALL WORK PERFORMED AND EQUIPMENT INSTALLED MEETS OR EXCEEDS THE NFPA70 2014 NATIONAL ELECTRIC CODE AND ALL OTHER LOCAL CODES AND ORDINANCES.
