**ORDER OF SUMMARY ADMINISTRATION
(intestate)**

**AMENDED PETITION FOR SUMMARY ADMINISTRATION
(intestate - single petitioner)**

Petitioner, Roosevelt Torrez Fluellen, alleges:

1. Petitioner has an interest in the above estate as sole beneficiary of the decedent. The Petitioner's address is set forth in paragraph 3 and the name and office address of the petitioner's attorney are set forth at the end of this petition.

2. Decedent, Ruthie Mae Rossin-Fluellen, whose last known address was 346 NE Christie Street, Lake City, Florida 32055, and, if known, whose age was 63 and the last four digits of whose social security number are 2754, died on January 14, 2014, at Lake City Medical Center, and on the date of death, decedent was domiciled in Columbia County, Florida.

3. So far as is known, the names of the beneficiaries of this estate, including the decedent's surviving spouse, if any, their addresses and relationships to decedent, and the dates of birth of any who are minors, are:

4. Venue of this proceeding is in this county because it was the county of the decedent's residence at the time of the decedent's death.

5. After the exercise of reasonable diligence, petitioner is unaware of any unrevoked wills or codicils of decedent.

6. Petitioner is entitled to summary administration because:
- a. To the best knowledge of the petitioner, the value of the entire estate subject to administration in this state, less the value of property exempt from the claims of creditors, does not exceed \$75,000.
7. Domiciliary probate proceedings are not known to be pending in another state or country.
8. The following is a complete list of the assets in this estate and their estimated values, together with those assets claimed to be exempt:

- b. The estate is not indebted.
- c. All creditors ascertained to have claims and who have not joined in the petition or consented to the order requested shall be served by formal notice with a copy of this petition.
- d. Petitioner acknowledges that any known or reasonably ascertainable creditor who did not receive timely notice of this petition and for whom provision for payment was not made may enforce a timely claim and, if the creditor prevails, shall be awarded reasonable attorney's fees as an element of costs against those who joined in the petition.


10. It is proposed that all assets of the decedent, including exempt property, be distributed to the following:
