Previous permit issued for 6.15 acres of impervious surface on 47.61 acres. Modification consists of construction and operation of a surfacewater management system serving a combined total of 39.59 acres of impervious surface on a total project area of 47.61 acres in a manner consistent with the application package submitted by Winsberg, Inc., certified on July 6, 2012.

It is your responsibility to ensure that adverse off-site impacts do not occur either during or after construction. Any additional construction or alterations not authorized by this permit may result in flood control or water quality problems both on and off site and will be a violation of District rule.
