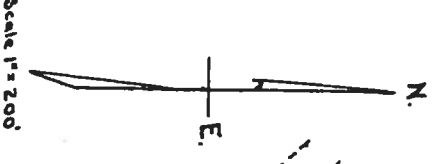


RUBY PARK

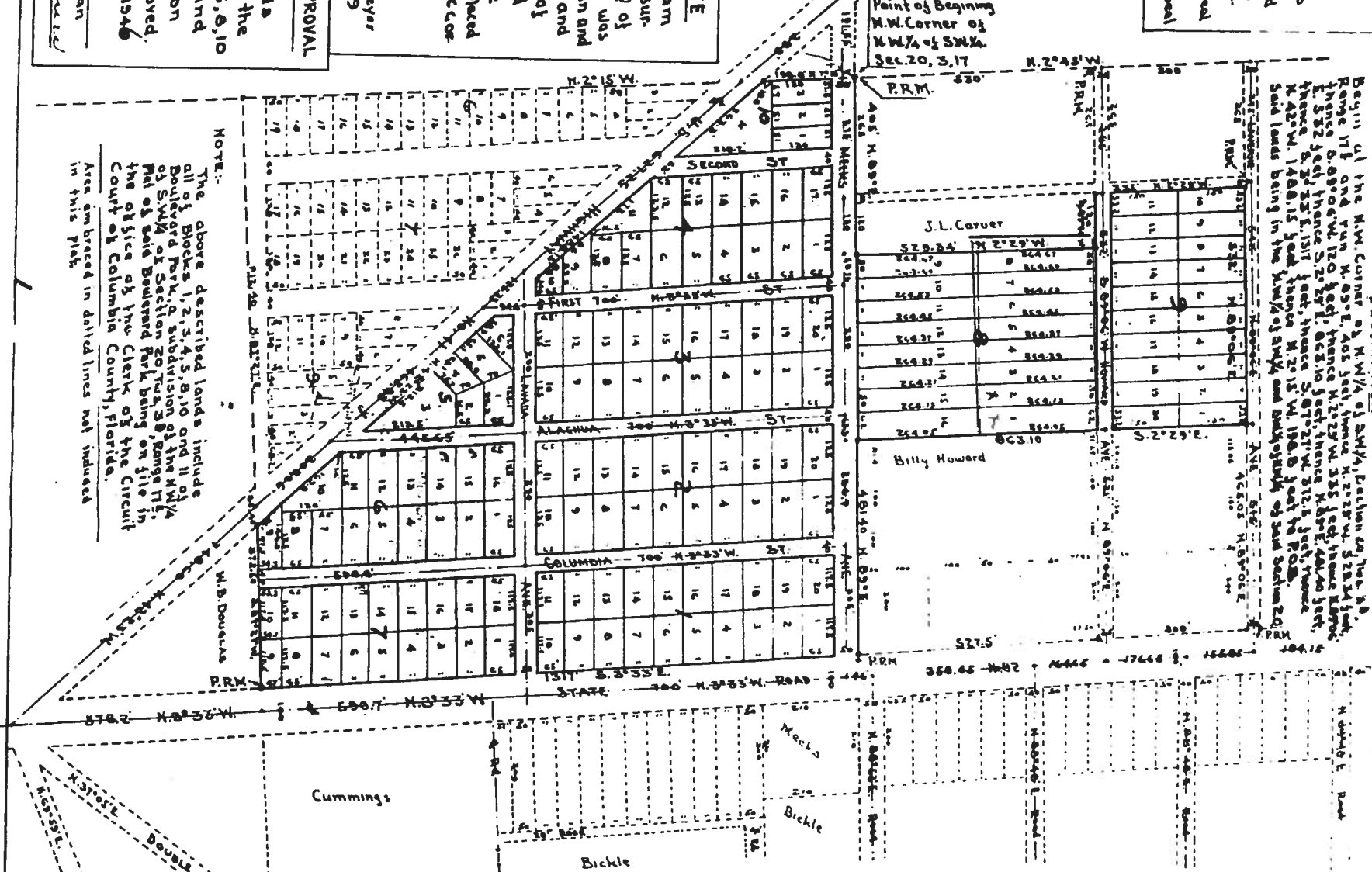


SURVEYORS CERTIFICATE
