As requested, I inspected the building site for the proposed construction at the above referenced site. The photos were taken from Memory Lane looking west and south. The topography of the property slopes to the west. Per the SRWMD Flood Report, there are no flood zones on the site. The wetland shown on the Flood Report is actually on the adjacent property.





The elevation of the road adjacent to the site varies between 87.9 + l- and 93.0 + l-. The existing ground elevation at building site is 82.7 + l-. The minimum finished floor elevation for a structure constructed on the referenced site shall be 85.36. The finished floor of the home will be below the nearest adjacent street. Elevations were determined from the Lidar elevations on the Columbia County website.

A swale will be graded uphill of the home to prevent direct precipitation runoff from impacting the home.
